CITY RESOLUTION NO. 468-09-2024

RESOLUTION ALLOWING THE REPAINTING OF PEDESTRIAN CROSSINGS (PED XING) WITHIN BONIFACIO STREET, FROM MERCURY DRUG (CORNER GONZAGA STREET) TO HOTEL ROMA, WITH THE SYMBOLIC RAINBOW COLORS IN OBSERVANCE AND SUPPORT OF THE PRIDE MONTH CELEBRATION FROM JUNE 13-30, 2024

WHEREAS, June is internationally recognized as Pride Month to honor the history, achievements and contributions of the LGBTQ+ community and to promote awareness and support for LGBTQ+ rights;

WHEREAS, the City Mayor, Hon. Maila Rosario S. Ting-Que, sent a letter to the Ninth City Council requesting for the passage of a resolution to repaint the Pedestrian Crossings (Ped Xing) in Bonifacio Street, from Mercury Drug (corner Gonzaga Street) to Hotel Roma, with the symbolic “Rainbow Colors” in observance of the Pride Month Celebration;

WHEREAS, Tuguegarao City recognizes and celebrates the diversity and inclusivity of its community and acknowledges the importance of promoting equality and acceptance for all individuals regardless of sexual orientation, gender identity or expression;

WHEREAS, the symbolic use of rainbow colors is widely recognized as a representation of LGBTQ+ pride and solidarity, and serves as a powerful visual statement of the city’s commitment to inclusivity and equality;

WHEREAS, repainting the pedestrian crossings on Bonifacio Street, from Mercury Drug (corner Gonzaga Street) to Hotel Roma, with the symbolic rainbow colors demonstrates the city’s support for the LGBTQ+ community during Pride Month;

WHEREAS, the portion to be painted should be between the existing white painted pedestrian lanes.


On motion of Hon. Dayag and without any objection, **CITY RESOLUTION NO. 468-09-2024** was **APPROVED** under suspended rules.
