WHEREAS, Officer-in-Charge of the Office of the City Mayor, Mr. Juanito A. Calubaquib, indorsed to the Ninth City Council the request of the Dupaya Recreation Center, Inc. to hold special derbies on various dates of September 2024;

WHEREAS, Section 10(D) of City Ordinance No. 32-08-2019 states that the City Mayor may issue permits for special cockfights, cock or stag derbies including cockfights via satellite participated in by cockers and breeders through invitations upon application duly approved by the Sangguniang Panlungsod through resolution of 30-working days before the scheduled playdate;

WHEREAS, the Dupaya Recreation Center, Inc. should adhere to traditional betting during its Special Derbies;

WHEREAS, upon deliberation of the said request, the Committee on Games, Entertainment and Amusement approved the following scheduled playdates to hold special derbies during Mondays and Wednesdays only:



RESOLVED FURTHER, to furnish a copy of this resolution to Dupaya Recreation Center, Inc. for information.


On motion of Hon. Mangada and without any objection, **CITY RESOLUTION NO. 487-09-2024** was **APPROVED** under suspended rules.
