SUBJECT:

Endorsement of the Memorandum of Agreement for the Optimization of Decision Support System for Effective e-Governance (ODeSSEE).

FOR THE PRESIDING OFFICER:

The Committee convened to discuss and deliberate on the endorsement by **City Administrator, Mr. Juanito A. Calubaquib**, of the draft **Memorandum of Agreement (MOA)**. The MOA establishes a collaborative partnership for the implementation of the **Optimization of Decision Support System for Effective e-Governance (ODeSSEE) Project**, aimed at strengthening communities in Cagayan.

The MOA parties are the **Tuguegarao City Government**, the **Department of Science and Technology-Regional Office II (DOST-RO2)**, **Isabela State University (ISU)**, and the **University of St. Louis Tuguegarao (USLT)**.

The Committee respectfully submits this **Committee Report** and has the honor to present before this august body the following **actions taken, findings, and recommendations**:

ACTIONS TAKEN:

The Committee conducted a thorough evaluation of the City Administrator's endorsement regarding the draft MOA on the ODeSSEE Project.

FINDINGS:

1. The Philippine government is committed to adopting the **United Nations Sustainable Development Goals (SDGs)** into its national development plans, specifically **SDG No. 11** ("Sustainable Cities and Communities") and other relevant SDGs.

2. **DOST-RO2** is mandated, as an implementing agency, to provide scientific and technological interventions to foster regional development.
3. The **Local Government Unit (LGU)** is committed to enhancing its economic infrastructure and promoting business opportunities through innovative technological solutions for the benefit of its constituents and potential investors.
4. The **Higher Education Institutions (HEIs)**-ISU and USLT-possess expertise in research, development, and technology transfer, and are mandated to extend generated technologies to target adopters, including LGUs.
5. The Parties desire to formally establish a collaborative partnership for the successful implementation of the **ODeSSEE** project towards Strengthening Communities in Cagayan Valley.
6. The general objective of the project is to establish an **integrated ODeSSEE dashboard** for pre-emptive planning in the three cities of the Cagayan Valley Region (Cauayan City, Santiago City, and Tuguegarao City) with the partner HEIs (Isabela State University-Echague and University of St. Louis Tuguegarao).
7. Project funding in the amount of **Eight Million Eight Hundred Thousand (P8.8 M)** shall be provided by DOST-RO2.
8. The technology/software was developed by **Isabela State University** for utilization by the concerned LGUs, with support from the academe in the training and capacity building on the system's usage, maintenance, and administration.
9. The implementation period for the project shall be **one (1) year**.
10. There is a need for the **creation of a Task Force ODeSSEE** for Tuguegarao City by the DOST to ensure effective project planning and execution.

RECOMMENDATIONS:


After a thorough discussion on the terms and conditions of the Memorandum of Agreement, the Committee finds the MOA to be in order and **beneficial to the City Government and its constituents**. The Committee favorably recommends its approval with the following recommendations/suggestions:


- a. The **City Disaster Risk Reduction and Management Office (CDRRMO)** shall designate a **point person from its office** to represent the Tuguegarao City Government for the proposed project.
- b. **Coordination with the Punong Barangays** concerning their role in the project's implementation.
- c. **DOST shall coordinate with the City Planning & Development Office (CPDO)** on data pertaining to agricultural, commercial, and no-build zones, and maintain close coordination with all concerned agencies regarding data profile gathering for integration purposes.
- d. **Maximize the use of existing technology** from other authorized agencies in the formulation of the ODeSSEE project.
- e. **Define all acronyms** within the Memorandum of Agreement for better understanding.
- f. The **City Legal Office shall coordinate with the concerned parties** to clearly define the roles and responsibilities of the Tuguegarao City Government.
- g. **Include the Chairman of the Committee on Peace and Order and Disaster Preparedness as one of the witnesses** in the MOA.


- h. **DOST shall coordinate with the City Legal Office** regarding the modification of the date of the project implementation.


Finally, the Committee recommends the **passage of a resolution authorizing the City Mayor to sign** the Memorandum of Agreement on behalf of the Tuguegarao City Government.



MEMORANDUM OF AGREEMENT

This MEMORANDUM OF AGREEMENT (hereinafter referred to as "MOA") is made and entered into this _____ day of _____, _____, by and among:

THE DEPARTMENT OF SCIENCE AND TECHNOLOGY - REGIONAL OFFICE II ("DOST R02"), a government agency created and existing under the laws of the Republic of the Philippines, with official address at #2 Dalan na Paccurofun, Corner Matunung St., Regional Government Center, Carig Sur, Tuguegarao City, Cagayan, represented herein by its Regional Director, DR. VIRGINIA G. BILGERA, (hereinafter referred to as "DOST R02");

and -

THE LOCAL GOVERNMENT UNIT OF TUGUEGARAO CITY, a local government unit duly organized and existing under the laws of the Republic of the Philippines, with official address at Carig Sur, Tuguegarao City, Cagayan, Philippines, represented herein by its City Mayor, HON. MAILA ROSARIO T. QUE, (hereinafter referred to as the "LGU");

and -

ISABELA STATE UNIVERSITY (ISU), a higher education institution duly created and existing under the laws of the Republic of the Philippines, with official address at San Fermin, Cauayan City, Isabela, represented herein by its University President, DR. BOYET L. BATANG (hereinafter referred to as the "HEI");

and -

UNIVERSITY OF ST. LOUIS TUGUEGARAO (USLT), a higher education institution duly created and existing under the laws of the Republic of the Philippines, with official address at Mabini St., Tuguegarao City, Cagayan, represented herein by its University President, REVEREND FATHER MACWAYNE NIMEZ MANIWANG, CICM, PHD (hereinafter referred to as the "HEI");

(DOST R02, the LGU, and the HEIs are hereinafter collectively referred to as the "Parties").

WITNESSETH THAT:

WHEREAS, the Philippine government is committed to adopting the United Nations Sustainable Development Goals into its national development plans and policies, specifically SDG No. 11 on "Sustainable Cities and Communities" and other relevant SDGs;

WHEREAS, the Parties acknowledge the importance of data-driven decision support systems for flood pre-emptive planning towards smarter cities and communities;

WHEREAS, DOST R02, as an implementing agency, is mandated to provide scientific and technological interventions to foster regional development;

WHEREAS, the LGU is committed to enhancing its economic infrastructure and promoting business opportunities through innovative technological solutions for the benefit of its constituents and potential investors;

WHEREAS, the HEI, possesses expertise in research, development, and technology transfer, and is mandated to extend generated technologies to target technology adopters, including LGUs;

WHEREAS, the Parties desire to formally establish a collaborative partnership for the successful implementation of the "ODeSSEE (Optimization of Decision Support System for Effective e-Governance) towards Strengthening Communities in Cagayan Valley" project (hereinafter referred to as the "Project");

NOW, THEREFORE, for and in consideration of the foregoing premises and the mutual covenants and undertakings hereinafter set forth, the Parties hereby agree as follows:

ARTICLE I: PROJECT TITLE AND OBJECTIVES

Section 1. Project Title. The Project covered by this MOA shall be entitled: "ODeSSEE (Optimization of Decision Support System for Effective e-Governance) towards Strengthening Communities in Cagayan Valley"

Section 2. General Objective. The general objective of the Project is to establish an integrated dashboard of ODeSSEE for flood pre-emptive planning for the 3 Cities of the Cagayan Valley Region.

Section 3. Specific Objectives. The specific objectives of the Project are:

- a. To customize and deploy the ODeSSEE dashboard for flood pre-emptive planning for the three cities (all barangays of Cauayan City and Santiago City and Tuguegarao City) in the region through the assistance of ISU-BIRDC;
- b. To conduct capability building with partner HEIs and LGUs City Disaster Risk Reduction Management Officers (CDRRMO) and Barangay Disaster Risk Reduction Management Officers using ODeSSEE; and
- c. To assess the usability of ODeSSEE using ISO 25010 software quality standards.

ARTICLE II: SCOPE OF COOPERATION AND RESPONSIBILITIES OF THE PARTIES

The Parties hereby agree to undertake the following roles and responsibilities for the successful implementation of the Project for a period of twelve (12) months, from April 2025 to March 2026:

Section 1. Responsibilities of DOST R02:

- a) Serve as the overall lead in the implementation, coordination, and monitoring of the Project.
- b) Create and facilitate the Technical Working Group (TWG) with the LGU and partner HEIs to ensure effective project planning and execution.
- c) Lead discussions with the TWG regarding project rationale, beneficiaries, objectives, and milestones.
- d) Develop and implement a comprehensive Communications Plan for the Project.
- e) Provide necessary funds as outlined in the approved Project Proposal and manage the overall budget for the Project.
- f) Oversee the technology transfer process, including seeking endorsement from the Regional Development Council (RDC) for the utilization of ODeSSEE technology by other LGUs in the region.
- g) Provide the final user manual and operations manual of the ODeSSEE to the LGU beneficiaries.
- h) Conduct regular monitoring and evaluation of the Project's progress and effectiveness.

Section 2. Responsibilities of the LGU:

- a) Designate an official Project Coordinator and a Technical Working Group to collaborate closely with DOST R02 and the HEI.
- b) Provide comprehensive five-year data relevant to the ODeSSEE, including but not limited to LGUs community data profile, flood hazard maps, City Disaster Risk Reduction Management Office (CDRRMO) profile and inventory resources as well evacuation profile of City's Social Welfare and Development.
- c) Collaborate with respective local agencies within the municipality (e.g., Office of Civil Defense – R2, LGU Disaster Risk Reduction Management Office (LDRRMO), Barangay Disaster Risk Reduction Management Council (BDRRMO), Local Department Social Welfare Development (DSWD), City Health Office.
- d) Provide barangay maps of the respective LGU in KML files or other suitable formats.
- e) Submit gathered data to the partner HEI for data cleaning and uploading processes.
- f) Submit timely periodic progress reports to DOST R02 as required.
- g) Ensure that all submitted data is accurate, complete, and validated by the appropriate local offices prior to submission to the HEI.

- h) Commit to allocate annual budget and designate personnel for the continued operation, updating, and sustainability of the ODeSSEE platform beyond the official project duration.
- i) Formulate and enact policies and guidelines relevant to the Project, including ordinances for the institutionalization and sustainability of the ODeSSEE.
- j) Ensure continuous updating of data within the ODeSSEE platform for real-time information.

Section 3. Responsibilities of the HEI:

- a) Provide technical assistance in the customization of the ODeSSEE tailored to the specific needs and processes of the identified LGUs.
- b) Assist in data migration and system integration for the ODeSSEE platform.
- c) Provide comprehensive training and capacity building to LGU staff and other partner HEIs on the ODeSSEE system's usage, maintenance, and administration.
- d) Conduct the data cleaning process on the raw data provided by the LGU.
- e) Upload the cleaned and validated data into the ODeSSEE platform.
- f) Closely monitor and work with the partner LGU to facilitate efficient data gathering.
- g) Conduct training for the LGU personnel down to the barangay level to ensure widespread understanding and utilization of the ODeSSEE.
- h) Assess the ODeSSEE using ISO 25010 software quality standards to evaluate its usability and performance.
- i) Establish a system for regular monitoring and evaluation of the ODeSSEE for LGU beneficiaries to gather feedback and identify areas for improvement, even after the completion of the Project.

ARTICLE III: FUNDING AND RESOURCES

Section 1. **Project Funding.** DOST R02 shall provide the funding for the Project.

Section 2. **LGU Contribution.** The LGU commits to providing counterpart resources, including but not limited to, personnel for data gathering and office space and equipment for activities as outlined in Article II, Section 2.

Section 3. **HEI Contribution.** The HEI commits to providing its facilities, technical expertise, and personnel to fulfill its responsibilities as outlined in Article II, Section 3.

ARTICLE IV: MONITORING AND EVALUATION

Section 1. **Regular Monitoring.** The Parties shall jointly conduct regular monitoring and evaluation activities to assess the progress, effectiveness, and impact of the Project, in accordance with the methodologies outlined in the approved Project Proposal.

Section 2. Reporting. The Parties shall submit periodic and final reports to their respective heads and to relevant oversight bodies as required, detailing the accomplishments, challenges, and recommendations related to the Project.

ARTICLE V: CONFIDENTIALITY

Section 1. Data Sharing. All data, information, and insights shared among the Parties for the purpose of this Project shall be treated with utmost confidentiality and shall not be disclosed to third parties without the prior written consent of the providing Party, except as required by law.

Section 2. Data Privacy. The Parties shall ensure strict compliance with the Data Privacy Act of 2012 (Republic Act No. 10173) and its Implementing Rules and Regulations in the collection, processing, storage, and sharing of all personal and sensitive personal information related to the Project.

ARTICLE VI: TERM AND TERMINATION

Section 1. Term. This MOA shall take effect upon the date of its signing by all Parties and shall remain in full force and effect for the duration of the Project, or until March 2026, unless earlier terminated as provided herein.

Section 2. Termination. This MOA may be terminated by mutual written agreement of all Parties or by any Party upon sixty (60) days prior written notice to the other Parties, in the event of a material breach of its terms and conditions that is not remedied within the notice period.

ARTICLE VII: AMENDMENTS

Any amendment, modification, or supplement to this MOA shall be valid only if made in writing and signed by duly authorized representatives of all Parties.

ARTICLE VIII: SEPARABILITY CLAUSE

Should any provision of this MOA be declared null and void by a competent court or authority, the same shall not affect the validity and enforceability of the other provisions hereof.

ARTICLE IX: EFFECTIVITY

This Memorandum of Agreement shall take effect immediately upon the signing thereof by all Parties.
