WHEREAS, this achievement brings honor and pride to our city, showcasing the talents and dedication of our youth in field of journalism.



RESOLVED FURTHER, to furnish a copy of this Resolution to Aaron Paulo B. Bautista of Barangay Centro 04 for his information.


