CITY RESOLUTION NO. 514-09-2024

RESOLUTION APPROVING THE HOLDING OF THE FIESTA CARNIVAL STARTING FROM JULY 30, 2024 TO AUGUST 30, 2024 FROM 3PM TO 12 MN, SUBJECT TO THE SUBMISSION OF ALL DOCUMENTARY REQUIREMENTS

WHEREAS, Section 458(4)(vii) of RA 7160, otherwise known as the Local Government Code of 1991, provides the powers of the Sangguniang Panlungsod to regulate the establishment, operation and maintenance of any entertainment or amusement facilities, including theatrical performances, circuses, billiard pools, public dance halls, sauna baths, massage parlors and other places for entertainment or amusement; regulate such other events or activities for amusement or entertainment, particularly those who tend to disturb the community or annoy the inhabitants, or require the suspension or suppression of the same; or, prohibit certain forms of amusement or entertainment in order to protect the social and moral welfare of the community;

WHEREAS, during normal days, part of the traditional fiesta celebration in Tuguegarao City is the holding of the Fiesta Carnival where people are given the time to enjoy more the festivities, hence, the conduct of the same will enliven the people’s celebration;

WHEREAS, any form of illegal gambling activity, such as: Drop Ball, 6/8, Color Game and other similar illegal gambling activities inside the carnival shall be a ground for the termination/stoppage of its operations, revocation of its permit and will be subject to legal actions against the operator;

WHEREAS, to ensure compliance with applicable laws and the regulatory measures herein provided, the Office of the City Mayor or through its authorized agent/representative is hereby empowered to enforce applicable laws, rules and regulations and/or to conduct inspection of any of the premises subject hereof on such date and time as it may deem necessary or as may be directed by the City Mayor. Its report shall be submitted to the City Mayor’s Office and the Sangguniang Panlungsod for their appropriate action;

WHEREAS, with the adoption of the concomitant committee report, the Ninth City Council during its 101st Regular Session held on July 30, 2024, approved the holding of the fiesta carnival starting on July 30, 2024 to August 30, 2024 from 3PM to 12MN subject for compliance by the operator of the following conditions:


1. To secure a Special Permit/Mayor's Permit;
2. To maintain cleanliness and sanitation within the premises;
3. To secure and ensure the safety of the vicinity by providing security personnel;
4. Not to extend the time and days of operation;
5. To pay the 10% Amusement Tax and other fees and charges as mandated by law;
6. To strictly comply with City Ordinance No. 80-08-2020, An Ordinance Prohibiting the Use of Karaoke, Videokes and Other Similar Sound Producing Gadgets that Disturb and Disrupt Modular and On-Line Classes Among Homes in the 49 Barangays of Tuguegarao City from Monday to Friday (7:00 AM to 7:00 PM) and Saturday (7:00 AM to 5:00 PM), and Providing Penalties for Violations Thereof;
7. To strictly comply with City Ordinance No. 12-09-2023, An Ordinance Imposing Curfew Hours for Minors to Prevent Juvenile Delinquency and Providing Penalties Thereof, with the exception provided under Section 5(3)-Minors who are in the company of their parents, guardians and proper authorities;
8. To strictly observe health protocols within the premises;
9. To provide fire extinguishers in every corner as a fire safety measure;
10. To install signages at the entrance and exit on the prohibited acts/games to inform the public;
11. No alcoholic drinks or drugs shall be in any way consumed or used within the area of peryas and/or carnivals; and,
12. To strictly observe health protocols within the premises.

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to approve the holding of the Fiesta Carnival starting from July 30, 2024 to August 30, 2024 from 3PM to 12MN, subject to the submission of all documentary requirements.


On motion of Hon. Mangada and without any objection, **CITY RESOLUTION NO. 514-09-2024** was **APPROVED**.
