WHEREAS, Republic Act No. 6847 creates and establishes the Philippine Sports Commission, Defining its Powers, Functions and Responsibilities, Appropriating Funds Therefor and for Other Purposes;

WHEREAS, Section 2 of Republic Act No. 6847 states that the policy of the State is to promote physical education, encourage and sustain the development of sports in the country to foster physical fitness, self-discipline, teamwork and excellence for the development of a healthy and alert citizenry through a unified national sports promotion and development program, and that the establishment and creation of a single, unified and integrated national sports policy-making body shall further this objective;

WHEREAS, Section 13 of RA 6847 states that the National Sports Associations, organized for their respective sports in the Philippines and/or affiliated with their respective international federations, are recognized by the International Olympic Committee;

WHEREAS, the Tuguegarao City Government recognizes the efforts of its citizens and institutions towards distinction that bring honor to the city, worthy of admiration and merit;

WHEREAS, the 6th Heroes Taekwondo International Championship 2024 hosted by Titiwangsa, Kuala Lumpur, Malaysia aimed to build and unify the World of Taekwondo enthusiasts worldwide;

WHEREAS, the competition which is under the concept of "Taekwondo for all" allows the participation of all genders and ages, from those under four to those over 60 and has provided an excellent opportunity to share knowledge on organizing a large tournament;



RESOLVED FURTHER, that a copy of this Resolution be forwarded to Hon. Aaron Robert A. Binarao for his information.


