

RESOLVED FURTHER, to furnish a copy of this resolution to the family of the late Hon. Rogelio Addun Tamayao for their information.


On motion of Hon. Ortiz and without any objection, **CITY RESOLUTION NO. 524-09-2024** was **APPROVED** under suspended rules.
