**RESOLUTION ATTESTING TO THE RESULT OF THE APPOINTMENT OF
MS. CAROLINA A. CALUCAG AS CITY GOVERNMENT
DEPARTMENT HEAD I (CITY CIVIL REGISTRAR)**

WHEREAS, it is the policy of the State to provide an efficient mechanism for Local Government Units to secure a functional and systematic governance that delivers an efficient and effective services;

WHEREAS, these mechanisms are enshrined under Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, Section 454(d) of the said Republic Act provides that Heads of departments and offices shall be appointed by the city mayor with the concurrence of the majority of all the sangguniang panlungsod members, subject to civil service law, rules and regulations. The sangguniang panlungsod shall act on the appointment within fifteen (15) days from the date of its submission, otherwise the same shall be deemed confirmed;

WHEREAS, the City Mayor, Hon. Maila Rosario S. Ting-Que, endorsed the appointment document of Ms. Carolina A. Calucag and was included in the 101st Regular Session of the Ninth City Council;

WHEREAS, the Ninth City Council deliberated through secret balloting on August 05, 2024 during the 102nd Regular Session for the appointment of Ms. Carolina A. Calucag;

WHEREAS, the said deliberation resulted into the non-concurrence of the aforementioned appointment with seven (7) members voting Yes and six (6) members voting No.


