**CITY RESOLUTION NO. 527-09-2024**

**RESOLUTION APPROVING AND AUTHORIZING THE RELEASE OF ONE MILLION ONE HUNDRED SEVENTY THOUSAND SEVEN HUNDRED ELEVEN PESOS AND THREE CENTAVOS (P1,170,711.03) BY THE DEVELOPMENT BANK OF THE PHILIPPINES AS ADDITIONAL FUNDS FOR THE CONSTRUCTION OF THE CITY DISASTER RISK REDUCTION AND MANAGEMENT OFFICE BUILDING**

**WHEREAS**, the City Mayor, Hon. Maila Rosario S. Ting-Que, has indorsed to the Ninth City Council a letter from Mr. Emil Antonio N. Calimag, Head of Tuguegarao Lending Center of the Development Bank of the Philippines, for the release of additional funds for the construction of City Disaster Risk Reduction and Management Office (CDRRMO) Building;

**WHEREAS**, the Tuguegarao City Government applied for a loan with the Development Bank of the Philippines in the amount of Thirty-Six Million Pesos (P36,000,000.00) for the construction of CDRRMO building and the said loan was approved by the said bank;

**WHEREAS**, the proposed City Disaster Risk Reduction and Management Office was originally bidded in the amount of Thirty-Four Million Eight Hundred Fifteen Thousand Three Hundred Thirty-One Pesos and Fifty-Eight Centavos (P34,815,331.58);

**WHEREAS**, the Tuguegarao City Government incurred an additional cost of One Million One Hundred Seventy Thousand Seven Hundred Eleven Pesos and Three Centavos (P1,170,711.03) in the construction of CDRRMO Building caused by cost overrun;

**WHEREAS**, the additional works in the construction of the new CDRRMO Building amounting to P1,170,711.03 has not been included in the original bidded price of Thirty-Four Million Eight Hundred Fifteen Thousand Three Hundred Thirty-One Pesos and Fifty-Eight Centavos (P34,815,331.58);

**WHEREAS**, the City Engineering Office submitted a program of work for the additional works in the construction of the CDRRMO Building;

**WHEREAS**, the new cost of the CDRRMO Building is now Thirty-Five Million Nine Hundred Eighty-Six Thousand Forty-Two Pesos and Sixty Centavos (P35,986,042.60).


**NOW, THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to approve and authorize the release of One Million One Hundred Seventy Thousand Seven Hundred Eleven Pesos and Three Centavos (P1,170,711.03) by the Development Bank of the Philippines as additional funds for the construction of the City Disaster Risk Reduction and Management Office Building.

**RESOLVED FURTHER**, to furnish a copy of this resolution to Mr. Emil Antonio N. Calimag, Head, Tuguegarao Lending Center, and Mr. Adonis M. Catabay, Branch Head, Tuguegarao Branch, Development Bank of the Philippines, for their information and appropriate action.


