**CITY RESOLUTION NO. 540-09-2024**

**RESOLUTION CREATING AN OVERSIGHT COMMITTEE TO OVERSEE THE IMPLEMENTATION OF CITY ORDINANCE NO. 23-2018, OTHERWISE KNOWN AS THE AMENDED TUGUEGARAO CITY MARKET CODE**

**WHEREAS**, Section 458 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers the Sangguniang Panlungsod to enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants;

**WHEREAS**, necessary thereto is the duty of the Sangguniang Panlungsod to oversee the implementation of ordinances to ensure their proper implementation;

**WHEREAS**, the letter of Mrs. Potenciana Perez (Mrs. Perez), one of the business operators at the Tuguegarao City Commercial Center (TCCC), asking for help regarding the incident that had happened to her at the TCCC, was included in the agenda, particularly, in the Information and Other Matters of the 103<sup>rd</sup> Regular Session of the Ninth City Council held on August 13, 2024;

**WHEREAS**, the City Treasurer, the Business Permits and Licensing Office (BPLO) Head, the Market Administrator and Mrs. Perez were invited to the 104<sup>th</sup> Regular Session as part of the Question Hour;

**WHEREAS**, there was a thorough deliberation on the incident that transpired at the TCCC involving Mrs. Perez, the Council has seen the need for the creation of an Oversight Committee;

**WHEREAS**, the Oversight Committee shall oversee the implementation of City Ordinance No. 23-2018, otherwise known as the Amended Tuguegarao City Market Code.

**NOW, THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to create an Oversight Committee to oversee the implementation of City Ordinance No. 23-2018, otherwise known as the Amended Tuguegarao City Market Code, to be composed of the following:


