**RESOLUTION APPROVING THE REQUEST OF DUPAYA RECREATION CENTER, INC. TO HOLD SPECIAL DERBIES ON NOVEMBER 4, 6, 11, 13, 18, 20, 25 AND 27, 2024 AND DECEMBER 2, 4, 9, 11, 16, 18, 23 AND 31, 2024 ONLY AND DENYING THE REQUEST OF SCHEDULED PLAYDATE ON DECEMBER 25, 2024**

**WHEREAS**, the City Mayor, Hon. Maila Rosario S. Ting-Que, indorsed to the Ninth City Council the request of the Dupaya Recreation Center, Inc. to hold special derbies on various dates for the months of November and December 2024;

**WHEREAS**, Section 10(D) of City Ordinance No. 32-08-2019 states that the City Mayor may issue permits for special cockfights, cock or stag derbies including cockfights via satellite participated in by cockers and breeders through invitations upon application duly approved by the Sangguniang Panlungsod through resolution of 30-working days before the scheduled playdate;

**WHEREAS**, the Committee did not approve the scheduled playdate on December 25, 2024, because it violates Section 11-E of City Ordinance No. 32-08-2019;

**WHEREAS**, after the discussion of the said request, the committee approved the following scheduled playdates only:

**WHEREAS**, Committee Report No. 243-2024 of the Committee on Games, Entertainment and Amusement recommending the approval of the request of the Dupaya Recreation Center, Inc. to hold

special derbies on November 4, 6, 11, 13, 18, 20, 25 and 27, 2024 and December 2, 4, 9, 11, 16, 18, 23 and 31, 2024 only was adopted during the 108<sup>th</sup> Regular Session of the Sangguniang Panlungsod.

**RESOLVED FURTHER**, to furnish a copy of this resolution to Dupaya Recreation Center, Inc. for information.


