**CITY RESOLUTION NO. 583-09-2024**

**A RESOLUTION OUTLINING THE RULES AND REGULATIONS FOR UNDAS 2024**

**WHEREAS**, All Saints’ Day is a solemn holy day of the Catholic Church dedicated to the saints of the Church celebrated annually on November 1 while All Souls’ Day dedicated to those who have died is observed on November 2 every year;

**WHEREAS**, as observed every year and as a part of Filipino traditions, there shall be a number of persons who shall go to cemeteries during the abovementioned days;

**WHEREAS**, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that “local government units are authorized to exercise powers necessary, appropriate or incidental for their efficient and effective governance and those which are essential to the promotion of general welfare”;

**WHEREAS**, the Ninth City Council during its 111<sup>th</sup> Regular Session held on October 15, 2024 deemed it necessary to outline the rules and regulations for UNDAS 2024 to maintain the solemnity and to ensure orderly and peaceful observance of All Saints’ Day and All Souls’ Day or UNDAS 2024;

**WHEREAS**, the rules and regulations outlined by the Ninth City Council include the following:

1. Prohibition on gambling activities
2. Prohibition on the use of loud sound equipment in cemeteries and memorial parks
3. Prohibition in the carrying of deadly weapons and the like
4. Prohibition of alcoholic beverages inside the cemeteries and memorial parks

**WHEREAS**, the segregation of wastes shall also be strictly enforced and ambulant vendors shall be given designated areas, too;



**WHEREAS**, the City Information Office shall cause the widest dissemination of this Resolution.
