**CITY RESOLUTION NO. 584-09-2024**

**RESOLUTION APPROVING THE DEED OF DONATION BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND THE PROVINCIAL GOVERNMENT OF CAGAYAN FOR THE DONATION OF A BRAND NEW WHEEL TYPE EXCAVATOR 0.3 CUBIC METER BUCKET CAPACITY-DIESEL AND AUTHORIZING THE CITY MAYOR, HON. MAILA ROSARIO S. TING-QUE, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID DEED OF DONATION**

**WHEREAS**, Section 455 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that local chief executives shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;

**WHEREAS**, the City Mayor, Hon. Maila Rosario S. Ting-Que, requested the Ninth City Council for an authority to sign for and on behalf of the Tuguegarao City Government the Deed of Donation with the Provincial Government of Cagayan for the donation of a Brand New Wheel Type Excavator 0.3 Cubic Meter Bucket Capacity-Diesel;

**WHEREAS**, the said donation was funded under the No Town Left Behind Program of the Provincial Government of Cagayan for the Year 2024;

**WHEREAS**, the Provincial Government of Cagayan donates the said equipment in the spirit of advancing public service and development within Tuguegarao City and for the benefit of its people;

**WHEREAS**, the Wheeled Backhoe shall be for public use and public purposes within the territorial jurisdiction of Tuguegarao City;

**WHEREAS**, the said equipment is described as follows:

**WHEREAS**, the Ninth City Council during its Special Session held on October 17, 2024 deemed it necessary to approve the herein request.


