RESOLUTION CONCURRING THE MEMORANDUM OF AGREEMENT BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND DR. JELIZA A. ALCANTARA, VISITING CONSULTANT/SPECIALIST AT THE TUGUEGARAO CITY PEOPLE’S GENERAL HOSPITAL

WHEREAS, Section 22(c) of Republic Act No. 7160, otherwise known as the Local Government Code, grants the power to the Local Chief Executive to enter into contracts on behalf of the local government unit with prior authorization by the Sanggunian concerned;

WHEREAS, the Ninth City Council in its 75th Regular Session held on November 23, 2022 approved City Ordinance No. 61-09-2022 titled “*An Ordinance Granting Continuing Authority to the City Mayor for and on Behalf of the Tuguegarao City Government to Enter into a Memorandum of Agreement with Visiting Consultants/Specialists of Tuguegarao City People’s General Hospital*”;

WHEREAS, the City Mayor, Hon. Maila Rosario S. Ting-Que, requested the Ninth City Council for concurrence on the renewal of the Memorandum of Agreement between the Tuguegarao City Government and Dr. Jeliza A. Alcantara, Visiting Consultant/Specialist with specialty in Obstetrics and Gynecologist at the Tuguegarao City People’s General Hospital;

WHEREAS, the Ninth City Council in its 113th Regular Session held on October 29, 2024 found the same to be meritorious and in order, and favorably recommended the approval of the said request.
