**WHEREAS**, Section 3, Article IX-B of the 1987 Constitution provides that the Civil Service Commission (CSC), as the central personnel agency of the Government, shall establish a career service and adopt measures to promote morale, efficiency, integrity, responsiveness, progressiveness and courtesy on the civil service;

**WHEREAS**, further under the aforementioned provision, the CSC shall strengthen the merit and rewards system, integrate all human resources development programs for all levels and ranks, and institutionalize a management climate conducive to public accountability, and shall submit to the President and the Congress an annual report on its personnel programs;

**WHEREAS**, as part of the government’s rewards and incentives mechanism under the Honor Awards Program of the CSC, the annual Search for Outstanding Government Workers (SOGW) aims to recognize civil servants who have shown utmost dedication and commitment to their work, as well as inspire other state employees toward deeper involvement in public service;

**WHEREAS**, among the SOGW awards given is the CSC Pagasa Award (Individual Category) which is bestowed to an individual for outstanding contributions that directly benefit more than one department of the government pursuant to Executive Order No. 292, s. m1987, otherwise known as the “Administrative Code of the Philippines,” and its Implementing Rules and Regulations;

**WHEREAS**, CSC Regional Office 02 has chosen **PASTOR C. TUMALIUAN, JR., DVM**, a resident of Atulayan Sur, Tuguegarao City, and department head of Tuguegarao City Veterinary Office, as regional awardee of the CSC Pagasa Award (Individual Category) under the HAP-SOGW Awards 2024;


