CITY RESOLUTION REQUESTING THE CAGAYAN 1 ELECTRIC COOPERATIVE, INC. (CAGELCO 1) FOR A MORATORIUM ON THE DISCONNECTION OF ELECTRIC SUPPLY AND TO WAIVE PENALTIES AND SURCHARGES UNTIL DECEMBER 31, 2024 DUE TO THE TYPHOONS AND FLOODS THAT HAVE BEEN RAVAGING THE CITY

WHEREAS, Tuguegarao City has been devastated by super typhoons Kristine, Leon, Marce and Nika for the past recent weeks;

WHEREAS, due to the effects of typhoon Kristine, Tuguegarao City was placed under a state of Calamity by virtue of Resolution No. 601, series of 2024 approved on November 7, 2024;

WHEREAS, according to PAGASA, there are two more typhoons, Ofel and Pepito, that shall be traversing Cagayan these coming days;

WHEREAS, Magat Dam has already started releasing water since November 11, 2024 which shall expectedly cause flooding in Tuguegarao;

WHEREAS, Tuguegarao City is considered the water basin in Region 2, thus, when typhoons occur and Magat Dam releases water, the city shall surely be submerged in water flood;

WHEREAS, CAGELCO 1 is hereby requested for a moratorium on disconnection and to waive and forgo penalties and surcharges including reconnection fees for the months of October and November 2024;

WHEREAS, the said request for moratorium and waiver of penalties and surcharges including the reconnection fee shall be up to December 31, 2024;



WHEREAS, the Ninth City Council prays for the granting of this request to help and assist those who belong to the marginalized sectors of the society.

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to request Cagayan 1 Electric Cooperative, Inc. (CAGELCO 1) for a moratorium on the disconnection of electric supply and to waive penalties and surcharges until December 31, 2024 in Tuguegarao City amidst the typhoons and floods that have been ravaging the city.
