WHEREAS, the Tuguegarao City Government recognizes individuals and athletes for bringing prestige and honor to their families and to Tuguegarao City.



RESOLVED FURTHER, to furnish a copy of this Resolution to Dr. Jay-Ar B. Bayani for his information.


