CITY RESOLUTION COMMENDING MC CHARLES M. MENDOZA OF BARANGAY BUNTUN FOR WINNING THE SILVER MEDAL UNDER 15-17 YEAR-OLD BANTAMWEIGHT JUNIOR DIVISION IN THE 6th HEROES TAEKWONDO INTERNATIONAL CHAMPIONSHIP HELD AT TITIWANGSA STADIUM, KUALA LUMPUR, MALAYSIA ON JULY 30 TO AUGUST 2, 2024

WHEREAS, Republic Act No. 6847 is an Act Creating and Establishing the Philippine Sports Commission, Defining its Powers, Functions and Responsibilities, Appropriating Funds Therefor, and for Other Purposes;
