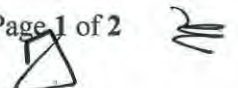

**WHEREAS**, Republic Act No. 6847 is an Act Creating and Establishing the Philippine Sports Commission, Defining its Powers, Functions and Responsibilities, Appropriating Funds Therefor, and for Other Purposes;

**WHEREAS**, Section 2 of RA 6847 states that the policy of the State is to promote physical education, encourage and sustain the development of sports in the country to foster physical fitness, self-discipline, teamwork and excellence for the development of a healthy and alert citizenry through a unified national sports promotion and development program, and that the establishment and creation of a single, unified and integrated national sports policy-making body shall further this objective;

**WHEREAS**, Section 13 of RA 6847 states that the National Sports Associations, organized for their respective sports in the Philippines and/or affiliated with their respective international federations, are recognized by the International Olympic Committee;

**WHEREAS**, the Tuguegarao City Government recognizes the efforts of its citizens and institutions towards excellence and distinction that bring honor to the City, worthy of admiration and merit;



**WHEREAS**, the 6<sup>th</sup> Heroes Taekwondo International Championship 2024 hosted by Titiwangsa, Kuala Lumpur, Malaysia aimed to build and unify the World of Taekwondo enthusiasts worldwide;

**WHEREAS**, **HESHVANN KIZHLEI B. CAINDEC**, 16 years of age, a resident of Barangay Ugac Norte, Tuguegarao City and the son of Mr. Napoleon J. Caindec and Ms. Genevieve B. 
