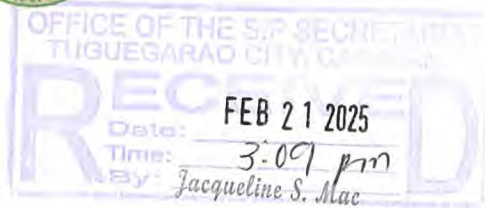

WHEREAS, the Local Government Code of 1991 (Republic Act No. 7160) empowers local government units, including barangays, to create and establish positions that are essential for the effective functioning and governance of local communities;

WHEREAS, the Sangguniang Barangay recognizes the importance of maintaining a safe and functional electrical system within the barangay, particularly with regard to streetlights and other electrical infrastructure that serve the community;

WHEREAS, the increasing need for effective monitoring and maintenance of the barangay’s electrical system, particularly streetlights, calls for the creation of a position for a Barangay Electrician to ensure the smooth operation and safety of these systems;

NOW, THEREFORE, BE IT ORDAINED by the Sangguniang Barangay of San Gabriel, as follows:

Section 1. Title

This Ordinance shall be known as the “Barangay Electrician Appointment, Duties and Responsibilities Ordinance.”

Section 2. Appointment of the Barangay Electrician

- The Punong Barangay shall appoint the Barangay Electrician subject to the concurrence/ confirmation of the Barangay Council, who shall serve under the supervision of the Punong Barangay and other barangay officials as deemed appropriate.
- The appointment shall be based on qualifications standard of an Electrician (preferably with license/ NCII Certificate), experience and technical expertise in electrical work, particularly in the maintenance and repair of streetlights and related electrical systems within the barangay.

Section 3. Definition of Terms

- Barangay Electrician - Refers to the appointed official responsible for the monitoring, maintenance and repair of streetlights and other electrical systems within the jurisdiction of Barangay San Gabriel.
- Streetlights - Refers to the electric lighting systems installed along streets, roads and public areas in the barangay for the purpose of ensuring visibility and safety at night.
- Electrical Systems - Includes all electrical infrastructure owned or operated by the barangay, including streetlights, public building lighting and other related systems.
- Maintenance and Repair - Refers to the regular checking, fixing and upgrading of electrical systems to ensure their proper functioning and compliance with safety standards.

Section 4. Primary Duties and Responsibilities

The Barangay Electrician shall have the following duties and responsibilities:

1. Monitor the condition of streetlights and other electrical systems within the barangay, identifying and addressing any issues promptly.

2. Perform maintenance and repair works on streetlights, electrical poles and other barangay-owned electrical systems to ensure proper functioning and safety.
3. Report any faulty or damaged electrical infrastructure to the Punong Barangay for necessary action or funding.
4. Ensure that electrical systems comply with safety regulations to prevent electrical hazards and accidents.
5. Assist in the installation of new streetlights or electrical systems as approved by the Sangguniang Barangay and the Punong Barangay.
6. Maintain a record of electrical repairs, maintenance activities and installations within the barangay.
7. Coordinate with local electric cooperatives or other agencies for the repair or maintenance of barangay-related electrical issues outside the scope of the barangay's capacity.
8. Perform other duties related to the barangay's electrical needs as directed by the Punong Barangay or the Sangguniang Barangay.

Section 5. Reporting and Accountability

- The Barangay Electrician shall provide regular reports to the Punong Barangay on the status of streetlights and other electrical systems, including ongoing repairs, maintenance schedules and any significant issues requiring attention.
- The Barangay Electrician must maintain transparency and adhere to the highest standards of ethical conduct in the execution of his duties.

Section 6. Funding

The compensation and necessary funds for the operation and responsibilities of the Barangay Electrician shall be sourced from the barangay fund.

Section 7. Separability Clause

If any provision of this Ordinance is declared invalid or unconstitutional, the remaining provisions shall remain in full force and effect.

Section 8. Repealing Clause

All barangay resolutions, ordinances or issuances inconsistent with this Ordinance are hereby repealed or modified accordingly.

Section 9. Effectivity Clause

This Ordinance shall take effect immediately upon its approval and posting in the barangay hall and other conspicuous places for public awareness.
