CITY RESOLUTION NO. 667-09-2024

RESOLUTION APPROVING THE DEED OF DONATION BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO) REGARDING THE DONATION OF A MEDICAL TRANSPORT VEHICLE AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. MAILA ROSARIO S. TING-QUE, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID DEED OF DONATION

WHEREAS, the Philippine Charity Sweepstakes Office (PCSO) is the principal government agency tasked to raise and provide funds for health programs, medical assistance and services, and the charities of national character;

WHEREAS, the PCSO, through the Medical Transport Vehicle Donation Program (MTVDP), aims to donate medical transport vehicles to Local Government Units (LGUs) which are essential for ensuring that patients can reach healthcare facilities in a timely and safe manner;

WHEREAS, the Patient Transport Vehicle (PTV) shall be used exclusively for transport of patients whose condition is of a non-life-threatening nature, affording them safe and comfortable conveyance, for medical outreach programs and as a service extension of the Tuguegarao City Government;

WHEREAS, pursuant to its mandate, the PCSO, upon approval by the Office of the President, procured PTVs for distribution to qualified beneficiaries;

WHEREAS, Tuguegarao City is a qualified beneficiary of the said transport vehicle;

WHEREAS, to complete the Donation, there is a need to request authority from the Sangguniang Panlungsod to allow the City Mayor to enter into and sign for and on behalf of the Tuguegarao City Government the Deed of Donation with Philippine Charity Sweepstakes Office regarding the donation of a Medical Transport Vehicle;



WHEREAS, upon the evaluation of the subject referral, the Joint Committee on Rules, Laws and Ethics and Committee on Health and Sanitation recommended for the approval of the Deed of Donation and the granting of authority to the City Mayor to sign for and on behalf of the Tuguegarao City Government the said Deed of Donation.

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to approve the Deed of Donation between the Tuguegarao City Government and Philippine Charity Sweepstakes Office (PCSO) regarding the donation of a Medical Transport Vehicle and to grant authority to the City Mayor, Hon. Maila Rosario S. Ting-Que, to sign for and on behalf of the Tuguegarao City Government the said Deed of Donation.


On motion of Hon. Baccay and without any objection, **CITY RESOLUTION NO. 667-09-2024** was **APPROVED**.
