**CITY RESOLUTION NO. 683-09-2024**

**RESOLUTION DENYING THE REQUEST OF THE DUPAYA RECREATION CENTER TO HOLD SPECIAL DERBIES ON FEBRUARY 3, 5, 10, 12, 17, 19, 24 AND 26, 2025**

**WHEREAS**, the City Mayor, Hon. Maila Rosario S. Ting-Que, indorsed to the Ninth City Council the request of the Manager of the Dupaya Recreation Center, Ms. Elizabeth G. Dupaya, for the holding of special derbies on February 3, 5, 10, 12, 17, 19, 24 and 26, 2025;

**WHEREAS**, Section 10(D) of City Ordinance No. 32-08-2019 states that the City Mayor may issue permits for special cockfights, cock or stag derbies including cockfights via satellite participated in by cockers and breeders through invitations upon application duly approved by the Sangguniang Panlungsod through resolution of 30-working days before the scheduled playdate;

**WHEREAS**, the indorsement was included in the 116<sup>th</sup> Regular Session held on November 19, 2024 and was referred to the Committee on Games, Entertainment and Amusement for proper action;

**WHEREAS**, Committee Report No. 297-2024 of the Committee on Games, Entertainment and Amusement was deliberated during the 119<sup>th</sup> Regular Session held on December 17, 2024;

**WHEREAS**, some members of the Ninth City Council asked and clarified about the justifications on the holding of special derbies;



**WHEREAS**, the matter was put into votation and with four (4) members voting against, three (3) members in favor and three (3) members abstaining, the request was denied.

**NOW, THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to deny the request of the Dupaya Recreation Center to conduct Special Derbies on February 3, 5, 10, 12, 17, 19, 24 and 26, 2025.
