**RESOLUTION GRANTING AUTHORITY TO THE USE OF THE SAVINGS OF THE
TUGUEGARAO CITY GOVERNMENT FOR THE GRANT OF A ONE-TIME SERVICE
RECOGNITION INCENTIVE (SRI) IN THE AMOUNT NOT EXCEEDING TWENTY
THOUSAND PESOS (P20,000.00) FOR ELIGIBLE GOVERNMENT EMPLOYEES
PURSUANT TO ADMINISTRATIVE ORDER NO. 27, SERIES OF 2024,
ISSUED BY PRESIDENT FERDINAND R. MARCOS, JR.**


WHEREAS, Administrative Order No. 27, series of 2024 Authorizing the Grant of Service Recognition Incentive (SRI) to Government Employees for Fiscal Year 2024 was signed by President Ferdinand R. Marcos, Jr. on December 13, 2024;

WHEREAS, Section 6 of the said Administrative Order states that the grant of one-time SRI to employees in LGUs, including those in the *barangays*, shall be determined by their respective *sanggunians* depending on the LGU's financial capability, subject to the PS limitation in LGU budgets under RA No. 7160 or the "Local Government Code of 1991," and the conditions set forth in Section 2 hereof, at a uniform rate not exceeding Twenty Thousand Pesos (P20,000.00), chargeable against their respective FY 2023 local government funds;"

WHEREAS, the City Mayor, Hon. Maila Rosario S. Ting-Que, requested for an authority to use the savings of the Tuguegarao City Government for the grant of a one-time Service Recognition Incentive (SRI) with a uniform rate not exceeding P20,000.00 to eligible government employees;

WHEREAS, the Ninth City Council during its Special Session held on December 19, 2024 deemed it beneficial to employees, hence, approved the said request.



NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to grant authority to the use of the savings of the Tuguegarao City Government for the grant of a one-time Service Recognition Incentive (SRI) in the amount not exceeding Twenty Thousand Pesos (P20,000.00) to eligible government employees pursuant to Administrative Order No. 27, series of 2024, issued by President Ferdinand R. Marcos, Jr.




On joint motion, **CITY RESOLUTION NO. 686-09-2024** was **APPROVED** under suspended rules.
