## RESOLUTION GRANTING AUTHORITY TO THE USE OF THE SAVINGS OF THE TUGUEGARAO CITY GOVERNMENT FOR THE GRANT OF GRATUITY PAY TO CONTRACT OF SERVICE AND JOB ORDER WORKERS

WHEREAS, the City Mayor, Hon. Maila Rosario S. Ting-Que, requested for the conduct of a Special Session on December 19, 2024 to discuss matters of urgency;

WHEREAS, one of the items enumerated by the City Mayor is the granting of Gratuity Pay to Contract of Service and Job Order workers of the Tuguegarao City Government in the event that a presidential issuance be issued on or before December 19, 2024;

WHEREAS, the Ninth City Council during the said Special Session held on December 19, 2024 deemed it necessary to approve the herein resolution for the grant of Gratuity Pay to Contract of Service and Job Order workers;

**WHEREAS**, the source of fund for the said Gratuity Pay shall be the Savings of the Tuguegarao City Government;

WHEREAS, the release of the said Gratuity Pay shall be subject to the provisions of the Presidential issuance from the Office of the President.

NOW, THEREFORE, RESOLVE, as it is hereby RESOLVED, to grant authority to the use of the savings of the Tuguegarao City Government for the grant of Gratuity Pay to Contract of Service and Job Order workers.
