SUBJECT:

Indorsement of the City Mayor, Hon. Maila Rosario S. Ting-Que, on Ibanag Council for Culture and the Arts (ICCA) Council Resolution No. 06-2025 Resolution Approving the Renaming and Adoption of the Ibanag Council for Culture and the Arts (ICCA) to Council for Culture and the Arts of Tuguegarao City (CCATC)

FINDINGS:

1. City Ordinance No. 053-2017, otherwise known as "An Ordinance Updating City Ordinance No. 10-2000, An Ordinance Creating the Ibanag Council of Culture and the Arts in Tuguegarao City" is essential in the revival, promotion and preservation of Ibanag Culture.
2. The Ninth City Council in its 142nd Regular Session held on June 24, 2025 approved City Ordinance No. 25-09-2025 titled "Ordinance Institutionalizing Programs for the Preservation, Promotion and Strengthening of All Languages, Dialects and Ethnicities in Tuguegarao City, Otherwise Known as the Tuguegaraoeno Ako! Ordinance of Tuguegarao City, Expanding and Amending for that Purpose the Specific and General Objectives Under Section 3 As Well As the Official Council Name Under Section 1 Of City Ordinance No. 053-2017 Or the Ordinance Updating City Ordinance No. 10-2000 Creating the Ibanag Council of Culture and the Arts in Tuguegarao City, and Providing Funds Thereof"
3. Tuguegarao City as the Capital of the Province of Cagayan and Regional Center of Cagayan Valley RO2 has developed as the Center of Excellence in Education, trade and commerce, hence, became a melting pot of different people, culture and ethnicities.

4. Section 4 Council Name of City Ordinance No. 25-09-2025 provides that “Ibanag Council on Culture and the Arts of Tuguegarao City is herein after referred to as the Council for Culture and the Arts of Tuguegarao City (CCATC)”
5. The Ibanag Council for Culture and the Arts approved Council Resolution No. 06, series of 2025 “Resolution Approving the Renaming and Adoption of the Ibanag Council for Culture and the Arts (ICCA) to Council for Culture and the Arts of Tuguegarao City (CCATC).

RECOMMENDATION:

Considering that Section 4 of City Ordinance No. 25-09-2025 already provided the renaming of the Ibanag Council for Culture and the Arts (ICCA) to Council for Culture and the Arts of Tuguegarao City (CCATC), the committee finds no need for further legislative action.


