The Members of the 10th City Council constituting as a Committee of the Whole, with the presence of members of the Local Finance Committee, Department Heads and Program Managers/Representatives, met on series of meetings to deliberate on the matter.

SUBJECT:

Indorsement of the City Mayor, Hon. Maila Rosario S. Ting-Que, on CDC Resolution No. 15-2025 Resolution Approving the CY 2026 Local Disaster Risk Reduction and Management Investment Plan (LDRRMIP) and Indorsing the Same to the August Sangguniang Panlungsod for Appropriate Action

Before this Committee is the Local Disaster Risk Reduction and Management Investment Plan (LDRRMIP) which is a document that outlines how a local government unit will allocate funds from its Local Disaster Risk Reduction and Management Fund (LDRRMF) to support disaster risk reduction and management activities.

Republic Act No. 10121, otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2020, mandates the Local Government Units to develop, promote and implement a comprehensive Local Disaster Risk Reduction and Management Plan. This law grants LGUs greater flexibility and responsibility for disaster mitigation, preparedness, response, rehabilitation and recovery efforts.

The City Disaster Risk Reduction and Management Office has formulated the CY 2026 Local Disaster Risk Reduction and Management Investment Plan (LDRRMIP) with various programs, projects and activities designed to strengthen disaster preparedness, response, recovery and rehabilitation efforts of the city. Hereunder is a table showing the details of the LDRRMIP for CY 2026 sourced under the LDRRMF. The breakdown of the total proposed amount, Eighty Three Million Nine Hundred Seventy Three Thousand Seven Hundred Pesos (Php83,973,700.00), outlined as follows:

The members of the committee reviewed the Programs of Work of the various PPAs under the 30% Quick Response Fund and 70% Disaster Prevention, Mitigation, Preparedness, Response and Recovery Fund as presented by the CDRRMO Head, Dr. Roderick Esteban B.

Ramirez. The other Programs of Work under the LDDRMF were presented respectively by Dr. Evangeline Calubaquib, Mr. Melvin Perez, Ms. Fe Mallari, Engr. Wenceslao Arao, Dr. Robin Zingapan and Mr. Jonathan Marcelo. Upon the request by the Committee, the office Project Procurement Management Plan (PPMF) of the various PPAs were submitted to support the programs of work.

During the course of deliberation, some members, however, raised their observations/suggestions/recommendations on the following PPAs:

Project: Equipage for DRRM Multi-Purpose Emergency Command Center (Fiber Optic network)

- Mr. Jonathan Marcelo submitted the detailed pictures and specifications of the various ICT Equipment and the location/areas where the existing 222 CCTVs were installed upon the request by the Committee.
- The Committee further suggested for Mr. Marcelo to conduct price canvassing of this ICT equipment which were quoted to have high estimates.
- To consider refining the Implementing Rules and Regulations (IRR), particularly on the procedures governing request for CCTV footage, and to ensure that such footage is not utilized for the unauthorized monitoring or tracking of private individuals in a manner that may infringe upon their right to privacy.

Project: Climate Change Resiliency and Disaster Risk Mitigation Program

- For the Bahayanihan Program (16 units): To prioritize indigent residents residing in flood-prone areas with dwellings made of lightweight materials, while the Bayanihan Program under the CSWDO (10 units) shall prioritize the poorest of the poor, landless residents of the city as beneficiaries.
- To refine/enhance the IRR for the Bayahanihan Program for the proper delineation of a beneficiary.

The proposed CY 2026 Local Disaster Risk Reduction and Management Investment Plan (LDRRMIP) was said to be consistent with NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 which outlined the policies and guidelines on the allocation of Local Disaster Risk Reduction and Management Fund (LDDRMF).


Thus, the Committee finds the various PPAs under the said Plan are aligned and within the framework of existing laws, rules and regulations and pertinent national laws.


This Committee therefore recommends the adoption and approval of CDC Resolution No. 15-2025 *Approving the CY 2026 Local Disaster Risk Reduction and Management Investment Plan (LDRRMIP)*, to be included as part of the supporting documents of the CY 2026 Annual Investment Program (AIP).

RECOMMENDATION:

IN VIEW OF THE FOREGOING, the Committee of the Whole expresses its support for the approval of the *CY 2026 Local Disaster Risk Reduction and Management Investment Plan (LDRRMIP)*. It is likewise recommended that a Resolution Adopting and Approving CDC Resolution No. 15-2025, *Resolution Approving the CY 2026 Local Disaster Risk Reduction and Management Investment Plan (LDRRMIP)* be approved in plenary.

CITY RESOLUTION APPROVING AND ADOPTING CITY DEVELOPMENT COUNCIL
(CDC) RESOLUTION NO. 15-2025 TITLED "APPROVING THE CY 2026 LOCAL DISASTER
RISK REDUCTION AND MANAGEMENT INVESTMENT PLAN (LDRRMIP)"

WHEREAS, Section 106 of the Local Government Code of 1991 provides that each local government unit shall have a comprehensive multi-sectoral development plan to be initiated by its development council and approved by its Sanggunian;

WHEREAS, the Office the City Mayor has endorsed to the Ninth City Council City Development Council (CDC) Resolution No. 15-2025 titled "Approving the CY 2026 Local Disaster Risk Reduction and Management Investment Plan (LDRRMIP) and Indorsing the same to the august Sangguniang Panlungsod for appropriate action" for its information and appropriate action;

WHEREAS, the members of the Sangguniang Panlungsod through its Committee of the Whole have conducted a series of deliberations with concerned department heads and employees for the discussion of the said CDC Resolution;

WHEREAS, in the said resolution, it is stated that the Local Disaster Risk Reduction and Management Council has identified the Programs, Projects and Activities (PPAs) necessary for quick response program, disaster mitigation and prevention, preparedness, response, rehabilitation and recovery for the benefit of all stakeholders and constituents;

WHEREAS, the Committee Report of the Committee of the Whole on the Local Disaster Risk Reduction and Management Investment Plan (LDRRMIP) CY 2026 of the City of the Tuguegarao, duly adopted and approved by majority of all members of the Sanggunian, is hereto attached and is hereby made an integral part of this resolution. The recommendations and conditions contained in the said report shall be the basis for the authorization of appropriation of each Program, Project, and Activity (PPA) as well as its implementation;

WHEREAS, the total amount of the 2026 Local Disaster Risk Reduction and Management Investment Plan (LDRRMIP) of Tuguegarao City is P183,973,700.00;

WHEREAS, the Tenth City Council during its 21st Regular Session held on November 28, 2025 found said CDC Resolution No. 15-2025 to be in order, with merit and beneficial to the constituents of the City;

WHEREAS, the Tenth City Council during its 21st Regular Session held on November 28, 2025 adopted Committee of the Whole Report No. 77-10-2025 adopting and approving CDC Resolution No. 15-2025 titled "Approving the CY 2026 Local Disaster Risk Reduction and Management Investment Plan (LDRRMIP) and Indorsing the same to the august Sangguniang Panlungsod for appropriate action"

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to approve and adopt CITY RESOLUTION APPROVING AND ADOPTING CITY DEVELOPMENT COUNCIL (CDC) RESOLUTION NO. 17-2025 TITLED "APPROVING THE CY 2026 LOCAL DISASTER RISK REDUCTION AND MANAGEMENT INVESTMENT PLAN (LDRRMIP)"
