Pursuant to Section 316(f) of the Local Government Code of 1991, the initial review of the Local Finance Committee on the **Sangguniang Kabataan Annual Budget for CY 2024 of Barangay Capatan** in the amount of **Five Hundred Fifty Two Thousand One Hundred Thirty Three Pesos and Eighty Centavos (P 552,133.80)** approved through **SK Resolution No. 6-2024** on March 5, 2024 shows substantial compliance with the provisions of the Code and its implementing rules and regulations.


