2.As per Information from the Punong Barangay of San Gabriel, the Loan proceeds in the amount of P6 million has already been approved and released by the Development Bank of the Philippines (DBP) and is included in the Annual Development Fund of the Barangay San Gabriel for the Calendar Year 2025.
