The joint committees met and deliberated on the referral:

SUBJECT:

INDORSEMENT OF THE CITY ADMINISTRATOR, MR. JUANITO A. CALUBAQUIB, ON THE LETTER OF MR. RONALD R. PABLO REGARDING HIS APPLICATION FOR CHANGE OF UNIT WITH THE RECOMMENDATION OF THE CITY LEGAL OFFICE.

ACTION TAKEN:

The committee met to discuss the subject matter with the presence of the resource persons.

FINDINGS:

1. City Administrator Mr. Juanito A. Calubaquib indorsed to the Tenth City Council the letter of Mr. Ronald R. Pablo regarding his application for change of unit with the recommendation of the City Legal Office.
2. The Tuguegarao City Tricycle Franchising Board met on November 18, 2025 at 2:00 PM to evaluate the documents submitted by applicant Mr. Ronald R. Pablo. After the evaluation, the Board approved a resolution authorizing Mr. Pablo of Barangay Pengue-Ruyu, Tuguegarao City to apply for a change of unit for his tricycle covered by a Provisional Authority to Operate a Tricycle for Hire, with Case No. 97-5933 and Plate No. 664BOG.
3. Atty. Maries M. Zalun-Alan of the City Legal Office stated that the Tricycle Regulation Unit (TRU) shall observe the following:
 - a. Given the subsisting Authority to Operate Tricycle for Hire (Franchise No. 97-5933), the TRU is directed to act on the application, provided that the applicant executes and submits a duly notarized Affidavit of Dropping, Cancellation, and Substitution of Unit;
 - b. The TRU shall ensure that Mr. Ronald R. Pablo presents and submits all required legal documents in accordance with Section 7 of the Tuguegarao City Tricycle Ordinance

of 2013 and settles the corresponding fees mandated under Section 8 of the same ordinance; and

- c. The TRU shall verify that the previously registered motorcycle unit is no longer serviceable or roadworthy, in accordance with the standards set forth under Section 16 of the Tuguegarao City Tricycle Ordinance of 2013.

4. Atty. Maries M. Zalun-Alan further stated that the 3rd and 5th Whereas Clauses of the Board Resolution should be amended to indicate that the applicant's motorized tricycle is already unserviceable, thereby rendering it no longer roadworthy, dependable, or reliable, to be consistent with Section 16(b) of City Ordinance No. 18-2013.

RECOMMENDATION:

After a thorough discussion and deliberation, the joint committees recommend the passage of a Resolution authorizing Mr. Ronald R. Pablo of Barangay Pengue-Ruyu, Tuguegarao City, to apply for a change of unit for his tricycle covered by a Provisional Authority to Operate a Tricycle for Hire, with Case No. 97-5933 and Plate No. 664BOG, subject to the conditions stated by the City Legal Office.

RESOLUTION AUTHORIZING MR. RONALD R. PABLO OF BARANGAY PENGUE-RUYU TUGUEGARAO CITY TO APPLY FOR CHANGE OF UNIT OF HIS TRICYCLE FOR HIRE SUBJECT TO THE COMPLIANCE WITH THE REQUIREMENTS AS PROVIDED IN ORDINANCE NO. 08-2013, TUGUEGARAO CITY FRANCHISING BOARD RESOLUTION NO. 01-2025 AND THE PAYMENT OF REQUISITE FEES

WHEREAS, the City Administrator, Mr. Juanito A. Calubaquib, endorsed to the 10TH City Council the letter of Mr. Ronald R. Pablo for a change of unit of his tricycle for hire for proper action;

WHEREAS, Board Resolution No. 01-2025 of the Tuguegarao City Franchising Board duly signed by the Members was approved authorizing Mr. Ronald R. Pablo of Barangay Pengue-Ruyu to apply for a change of unit of his tricycle covered by provisional authority to operate tricycle for hire with Case No. 97-53;

WHEREAS, after the Joint Committees on Transportation and Rules, Laws and Ethics deliberated on the subject matter, the committee found the request to be proper and meritorious considering this was supported by a Police Report dated October 2, 2025, Recommendations of the City Legal Officer and Board Resolution No. 01-2025 of the Tuguegarao City Franchising Board;

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, by the Tenth City Council to authorize Mr. Ronald R. Pablo of Barangay Pengue Ruyu, Tuguegarao City to apply for a change of unit of his tricycle for hire subject to the compliance with the requirements as provided in Ordinance No. 08-2013, Tuguegarao City Franchising Board Resolution No. 01-2025 and the payment of requisite fees.

RESOLVED FURTHER, to forward copies of this Resolution to Mr. Ronald R. Pablo and to the Tuguegarao City Franchising Board for information and appropriate action.
