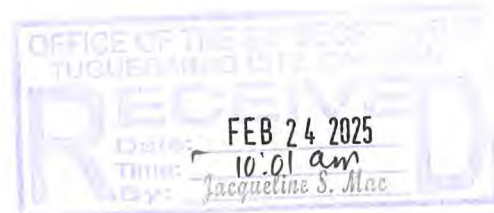




Ladies and Gentlemen:


**Ladies and Gentlemen:**

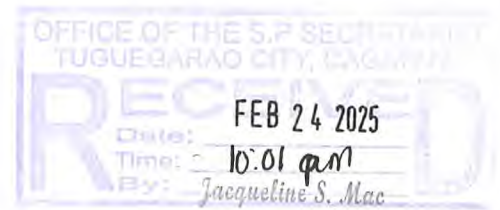




