Pursuant to Section 316(f) of the Local Government Code of 1991, the initial review of the Local Finance Committee on the Sangguniang Kabataan Annual Budget for CY 2024 of Barangay Tanza in the amount of Eight Hundred Thirty Thousand Three Hundred Eighty Five Pesos and Ninety Centavos (P 830,385.90), approved through SK Resolution No. 2-2024 on March 17, 2024 shows substantial compliance with the provisions of the Code and its implementing rules and regulations.
