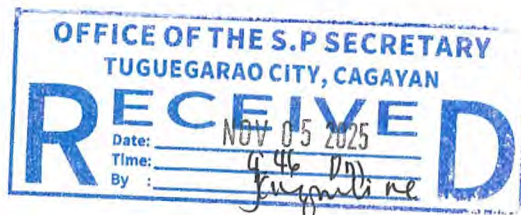

MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement made and entered into this _____ day of _____, 2025 at Tuguegarao City, Philippines by and between:

The **PROVINCIAL GOVERNMENT OF CAGAYAN** with principal office address at the Capitol Hills, Tuguegarao City, Cagayan, herein represented by its Provincial Administrator, **ATTY. MARIA ROSARIO MAMBA-VILLAFLO**R, herein referred to as the **First Party**;

and

TUGUEGARAO CITY CAGAYAN with principal office address at Enrile Boulevard, Carig Sur, Tuguegarao City, Cagayan represented by its **City Mayor, HON. MAILA ROSARIO S. TING- QUE**, herein referred to as the **Second Party**;

WITNESSETH:

RECITALS IN SUPPORT OF THE DEVELOPMENT ASSISTANCE TO LGUs- NO TOWN LEFT BEHIND- NTLB (FUND TRANSFER)

WHEREAS, under Section 33 of RA 7160 otherwise known as the Local Government Code of 1991, Local Government Units may undertake cooperative undertakings for the common benefit of their constituents;

WHEREAS, the Provincial Government of Cagayan sees the importance of such joint undertaking for effective local governance in promoting good governance and general welfare;

WHEREAS, the Provincial Government of Cagayan is extending financial assistance amounting to THREE MILLION PESOS (Php3,000,000.00) funded under the CY 2025 Development Assistance to LGUs No City/No Town Left Behind- NTLB (Fund Transfer) of the Province to the Second Party which shall be utilized for the implementation of the identified priority infrastructure project of the City;

WHEREAS, both Parties recognize that inter-LGU cooperation and resource-sharing are lawful and encouraged mechanisms under the Local Government Code to ensure effective and efficient delivery of services;

NOW THEREFORE, for and in consideration of the general welfare of the residents of the City of Tuguegarao Cagayan, both parties voluntarily agree and stipulate the following terms and conditions:

SECTION 1. THE PROJECT. This Agreement establishes the terms and conditions governing the transfer of funds from the Provincial Government of Cagayan to the City of Tuguegarao the aggregate amount of **THREE MILLION PESOS (P3,000,000.00)**. The amount of Three Million Pesos (Php3,000,000.00) as an implementation of the CY 2025 Development Assistance to LGUs No City/No Town Left Behind- NTLB (Fund Transfer) must be utilized for the Concreting of Road in Barangay San Gabriel, Tuguegarao City which is the identified priority infrastructure project of the City of Tuguegarao.

SECTION 2. RELEASE AND USE OF PROJECT FUNDS. The First Party shall release to the Second Party the aggregate amount of THREE MILLION PESOS (P3,000,000.00) within _____ days from the signing of this MOA. The Second Party shall use the project only for the above-mentioned project;

SECTION 3. PERIOD OF IMPLEMENTATION. The project has to be implemented within _____ days from the release of the fund to the Second Party;

SECTION 4. MONITORING. The First Party shall monitor the implementation of the project in conformity with the approved Program of Work and specifications submitted;

SECTION 5. REPORT AND LIQUIDATION. The Second Party shall provide the First Party with the appropriate report of implementation and will liquidate the project funds within thirty (30) days from the completion of the project or prior to the granting of succeeding financial assistance, if any. The Second Party, upon request of the First Party shall make available all papers, documents, reports and records relating to the project for inspection and examination.

SECTION 6. AMENDMENT. Any modification or amendment of the terms, conditions and covenants under this Memorandum of Agreement, in order to be valid and binding must be mutually agreed upon in writing by the Parties.

SECTION 7. EFFECTIVITY. This Agreement shall take effect on the date of signing hereof by the Parties and shall be terminated upon satisfactory fulfilment of all terms and conditions embodied herein.
