“**RESOLVED FINALLY**, that in the case of financial assistance, the same shall be liquidated after completion of the purpose for which it was given, and that no fund releases shall be made to any party with unliquidated financial assistance.”

3. That the above resolution is in full force and effect and has not been altered, amended or revoked to date.
