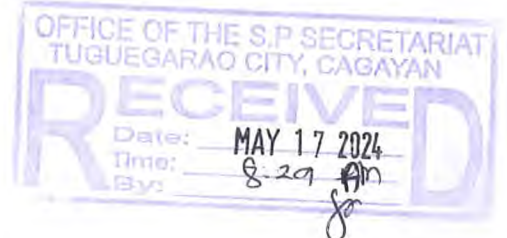

2. Taft Street to Aguinaldo Street intersection.

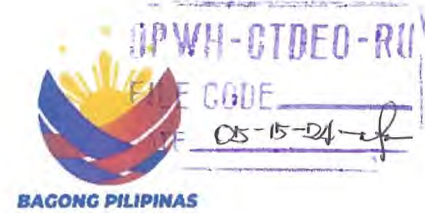
