

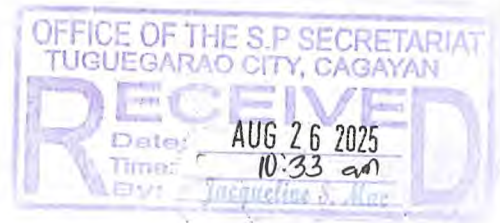

Greetings!

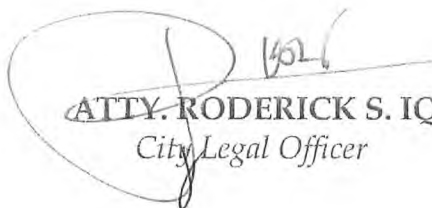
We respectfully endorse to your office the attached list of current tenants at the Tuguegarao City Commercial Center whose contracts of lease are due for renewal.
