



### MEMORANDUM OF AGREEMENT

### KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2025 at Tuguegarao City, Philippines by and between:

The **PROVINCIAL GOVERNMENT OF CAGAYAN** with principal office address at Capitol Hills, Tuguegarao City, Cagayan, herein represented by its Provincial Administrator, **ATTY. MARIA ROSARIO MAMBA-VILLAFLOR**, herein referred to as the **First Party**;

and

TUGUEGARAO CITY CAGAYAN with principal office address at Enrile Boulevard, Carig Sur, Tuguegarao City, Cagayan represented by its City Mayor, HON. MAILA ROSARIO S. TING- QUE, herein referred to as the Second Party;

### WITNESSETH:

## RECITALS IN SUPPORT OF THE FUND TRANSFER FOR THE SUPPORT TO LGU AGRICULTURAL PROGRAM

WHEREAS, the Republic Act No. 11321, otherwise known as the "Sagip Saka Act," institutionalizes the Farmers and Fisherfolk Enterprise Development Program (FFEDP) which seeks to improve the income of farmers and fisherfolk through productivity enhancement, market access, and enterprise development;

WHEREAS, Department of Agriculture Administrative Circular No. 08 Series of 2019 with subject "The Implementing Rules and Regulations of Republic Act No. 11321 "An Act Instituting the Farmers and Fisherfolk Enterprise Development Program of the Department of Agriculture" encourage the cooperation of national government agencies and local government units (LGUs) in implementing projects and activities that support agricultural and fishery enterprises;

WHEREAS, Section 17 of Republic Act No. 7160, otherwise known as the *Local Government Code of 1991*, empowers local government units to discharge functions and responsibilities for the general welfare of their constituents, including agricultural development programs;

WHEREAS, Section 25(b) of the same Code provides that the Provincial Government shall ensure that municipal governments act within the scope of their prescribed powers and functions, and may provide financial, technical, or material assistance to component municipalities when necessary;

WHEREAS, pursuant to the foregoing, the Provincial Government of Cagayan has allocated funds under its Supplemental Budget No. 1 for the Year 2025 for the implementation of the Fund Transfer for the Support to LGU Agricultural Programs, to support agricultural productivity and market linkage initiatives in component municipalities with an allocated amount of THREE MILLION PESOS (Php3,000,000.00) per municipality and city;

**NOW THEREFORE**, for and in consideration of the general welfare of the residents of the City of Tuguegarao Cagayan, both parties voluntarily agree and stipulate the following terms and conditions:

**SECTION 1. THE PROJECT.** This Agreement establishes the terms and conditions governing the transfer of funds from the Provincial Government of Cagayan to the City of Tuguegarao the aggregate amount of **THREE MILLION PESOS (P3,000,000.00).** The amount of Three Million Pesos (Php3,000,000.00) as an implementation of the Fund Transfer for the Support to LGU Agricultural Programs must be utilized for <u>buying and selling of palay and other agricultural produce and/or agriculture related products</u>.

**SECTION 2. RELEASE AND USE OF PROJECT FUNDS.** The First Party shall release to the Second Party the aggregate amount of THREE MILLION PESOS (P3,000,000.00) within \_\_\_\_\_ days from the signing of this MOA. The Second Party shall use the project only for the above-mentioned project;

**SECTION 3. PERIOD OF IMPLEMENTATION.** The project has to be implemented within \_\_\_\_\_ days from the release of the fund to the Second Party;

**SECTION 4. MONITORING.** The First Party shall monitor the implementation of the project in conformity with the approved Program of Work and specifications submitted;

**SECTION 5. REPORT AND LIQUIDATION.** The Second Party shall provide the First Party with the appropriate report of implementation and will liquidate the project funds within thirty (30) days from the completion of the project or prior to the granting of succeeding financial assistance, if any. The Second Party, upon request of the First Party shall make available all papers, documents, reports and records relating to the project for inspection and examination.

**SECTION 6. AMENDMENT.** Any modification or amendment of the terms, conditions and covenants under this Memorandum of Agreement, in order to be valid and binding must be mutually agreed upon in writing by the Parties.

**SECTION 7. EFFECTIVITY.** This Agreement shall take effect on the date of signing hereof by the Parties and shall be terminated upon satisfactory fulfilment of all terms and conditions embodied herein.
