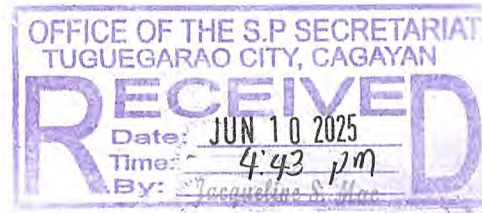



Dear Mayor Ting-Que:

This refers to the project of this office with **Contract Id No: 24B00094, Organizational Outcome 1: Ensure Safe and Reliable National Road System – Asset Preservation Program – Construction/Upgrading/Rehabilitation of Drainage Along National Roads – Primary Roads Cagayan Valley Roads – K0477+230.40 – K0477+714.70**, under contract with Double J1908 Construction.

The construction of the said project requires the removal/demolition of the Peñablanca Welcome Arch; hence we respectfully request for assistance for the temporary closure of the National Road and diversion of traffic from NGN Gran Hotel to Baker's Percent Building (beside the access road adjacent to MM Michael Mark Clean Fuel Station).

The proposed alternate route going to and from the City Proper is presented in the attached proposed plan.

The temporary closure of the above-mentioned section of the National Road shall ensure safety of all motor vehicles and shall prevent any damage/accident while the demolition is on-going.
