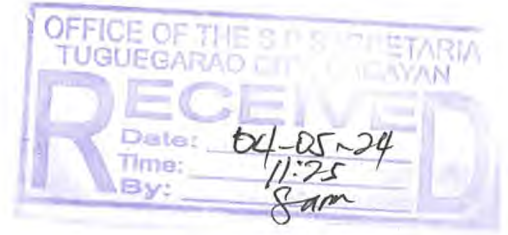



WHEREAS, registration of Lavadia Street will be benefit the constituents in the said area.


