Council Resolution No. **04**, series of 2023

**ADOPTING AND APPROVING THE CAMP COORDINATION AND CAMP
MANAGEMENT PLAN OF TUGUEGARAO CITY**

WHEREAS, Section 16 of Republic Act No. 7160 or the Local Government Code of 1991 provides that every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, within their respective territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, Section 17 of the Code mandates the local government units to be self-reliant and shall continue exercising the powers and discharging the duties and functions currently vested upon them;

WHEREAS, Republic Act No. 10121 otherwise known as Philippine Disaster Risk Reduction and Management Act of 2010, declares a policy enjoining government agencies and instrumentalities to adopt and implement a coherent, comprehensive, integrated, efficient and responsive disaster risk reduction program incorporated in the development plan at various levels of government adhering to the principles of good governance such as transparency and accountability within the context of poverty alleviation and environmental protection;

WHEREAS, the Department of Social Welfare and Development (DSWD), Department of the Interior and Local Government (DILG), Department of Health (DOH), and Department of Education (DepEd) have issued the Joint Circular No. 02 series of 2021 which enumerates the guidelines on Camp Coordination and Camp Management for Internally Displaced Persons;

WHEREAS, following the said statutory provisions and administrative regulations and in the interest of public service, the offices of the Tuguegarao City Government, in consultation the members of the City Disaster Risk Reduction and Management Council and other stakeholders, have formulated the Camp Coordination and Camp Management Plan of Tuguegarao City which includes the following:

- i. Collaborative strategies and protocols on the management of evacuation centers;
- ii. Provision of necessary support to evacuees especially the vulnerable sectors such as women, children, and persons with disabilities;
- iii. Deployment of necessary manpower and resources to identified evacuation sites; and
- iv. Other contingency measures

WHEREFORE, in view of the foregoing, the Tuguegarao CDRRMC acting as a collegial body, in quorum, **RESOLVES** to **ADOPT** the resolution approving the Camp Coordination and Management Plan of Tuguegarao City.


On joint motion of the members present during the meeting, this Tuguegarao CDRRMC Resolution is hereby **APPROVED**.
