



Partner with CSU researchers for ongoing evaluation and refinement of interventions to ensure sustained effectiveness and establish a long-term academic-governmental partnership that extends beyond VAWC cases to address other significant local challenges.

We firmly believe that this partnership represents a meaningful opportunity to combine the academic expertise of CSU with the operational capabilities of the LGU to create impactful and lasting change for Tuguegarao City.

MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement is entered into between:

The TUGUEGARAO CITY GOVERNMENT, a Local Government Unit, represented by HON. MAILA ROSARIO TING- QUE in her capacity as City Mayor, with office address Enrile Boulevard, Carig Sur, Tuguegarao City, hereinafter referred to as "LGU;"

-and-

CAGAYAN STATE UNIVERSITY (CSU), a higher education institution created by virtue of Presidential Decree No. 1436 and operating under the laws of the Republic of the Philippines, with principal address at Andrews Campus, Caritan Sur, Tuguegarao City, duly represented by its Officer-In-Charge, Office of the University President, ARTHUR G. IBAÑEZ, Ph.D., ASEAN ENGR., herein referred as "CSU".

-WITNESSETH-

WHEREAS, one of the principles under RA 10354 or the Responsible Parenthood and Reproductive Health (RPRH) Act of 2012, provides for the protection and fulfilment of reproductive health and rights which seeks to promote the rights and welfare of every person particularly couples, men, women, adolescents and all other adult individuals;

WHEREAS, the RPRH Law provides that the definition of reproductive health implies that women and men attain equal relationships in matters related to sexual relations and reproduction. It also includes male responsibility and involvement, and men's reproductive health as one of the 12 reproductive health elements;

WHEREAS, the RPRH Law provides for the active participation of institutions/agencies or organizations that are faith or community-based including non-government organizations (NGOs), civil society organizations (CSOs) and private institutions to strengthen the implementation of the law and ensure wider reach of reproductive health services giving priority to women, the poor and the marginalized;

WHEREAS, the TUGUEGARAO CITY GOVERNMENT through its (Adolescent Health and Development (AHD) Program recognizes the significant contribution of the youth (whose age ranges from 15 to 30 years) which comprises about 28.9% of the country's population in 2020 to the over-all achievement of human and socio-economic development of the nation);

WHEREAS, the full and integrative development of young people in the country is critically challenged by existing and emerging concerns particularly those affecting their health, including sexuality and reproductive health concerns, the issues on increasing teenage pregnancy, incidence of sexually transmitted infections and HIV/AIDS, illegal drugs and substance use and abuse, smoking, and other related issues;

WHEREAS, Executive Order No. 141, series 2021, espouses "Adopting as a National Priority the Implementation of Measures to Address the Root Causes of the Rising Number of Teenage Pregnancies, and Mobilizing Government Agencies for the Purpose." Said order adopts as a national policy the implementation of measures to tackle the root causes of the rising number of young Filipinos giving birth;

WHEREAS, the State shall mobilize existing coordinative and functional mechanisms related to the prevention of adolescent pregnancies. It also includes interventions for the prevention of adolescent pregnancies such as comprehensive sexuality education, education and employment opportunities for the young, as well as health promotion through media and other communication platforms;

WHEREAS, EO 141 also calls for youth and community mobilization, as Sangguniang Kabataan (SK) units are also enjoined to develop interventions and prevent all known causes of adolescent pregnancies, while supporting adolescent mothers;

WHEREAS, TUGUEGARAO CITY GOVERNMENT (is part of the larger Zonta International organization, is driven by a clear and compelling purpose: to create a world where every woman and girl can achieve her full potential without fear of violence or discrimination. With this vision in mind, the Zonta Club's advocacy efforts are deeply rooted in the promotion of gender equality and the empowerment of women and girls across the globe. At its core, the Zonta Club's mission is to build a better world by improving the legal, political, economic, educational, health, and professional status of women. The organization fervently believes that women's rights are human rights and tirelessly works to ensure that these rights are recognized and upheld in all spheres of life).

WHEREAS, the adolescents and young people are the foundation of our future and the significant contributor to current development;

WHEREAS, TUGUEGARAO CITY GOVERNMENT (recognizes the important roles of men in responsible parenthood and family planning and adopted effective strategies in educating males through the conduct of KATROPA (Kalalakihang Tapatsa Responsibilidad at Obligasyon sa Pamilya);

WHEREAS, CSU is an academic institution offering programs under the College of Business, Entrepreneurship, and Accountancy, committed to academic excellence and community service:

WHEREAS, CSU as a sustainable center of excellence for education, health and business and entrepreneurship through science-based multidisciplinary researches in support to needs-based extension and science-based instruction in Cagayan;

WHEREAS, recognizing that only a long-term strategy will ensure the desired outcomes, TUGUEGARAO CITY GOVERNMENT and CSU are joining forces and formally launching this multi-sectorial initiative to protect the rights of vulnerable girls and prevent them from marrying too young and to support those already married girls; and to reach out to men who are vital partners in the promotion of gender equality and in the prevention of violence against women and girls;

WHEREAS, the advocacy campaigns and other interventions of TUGUEGARAO CITY GOVERNMENT will greatly contribute in attaining the goals of CSU-CBEA and the University's Research and Extension Program on the community;

WHEREAS, to effectively advocate TUGUEGARAO CITY GOVERNMENT programs, projects, activities and interventions to all the target clients/audiences is through meaningful partnership with other institutions/organizations like Cagayan State University – College of Business, Entrepreneurship and Accountancy (CSU-CBEA);

NOW THEREFORE, for and in consideration of the foregoing, CITY GOVERNMENT OF TUGUEGARAO and the Cagayan State University – College of Business, Entrepreneurship and Accountancy, hereunto agree to undertake the following:

I. PURPOSE OF THE AGREEMENT AND FORMATION OF PARTNERSHIP

CITY GOVERNMENT OF TUGUEGARAO and CSU-Andrews through CBEA hereby commit to actively (participate in the conceptualization, development and production of SBCC Materials on IPV); promotion and advocacy of all CITY GOVERNMENT OF TUGUEGARAO and CSU-CBEA research study titled, "Breaking Cycles of Abuse: Empowering women through Primary support and Advocacy interventions in Intimate Partner Violence;" (as well as programs, projects and activities and collaboration of all efforts and initiatives to address the alarming issue of adolescent pregnancy, violence against women and children (VAWC); and to intensify male involvement on responsible parenthood and family planning through the "Kalalakihang Tapat sa Responsibilidad at Obligasyon sa Pamilya" o KATROPA; women empowerment; gender equality and many others.)

II. ROLES AND RESPONSIBILITIES OF PARTIES

Each party to this agreement hereby commits to perform the following roles and responsibilities:

A. TUGUEGARAO CITY GOVERNMENT will:

- Provide technical assistance and support in the conceptualization, development and production of SBCC materials and conduct of SBCC activities on Adolescent Pregnancy and Child Marriage; VAWC; ProtecTEEN, KATROPA and other interventions;
- 2. Include the discussion of the research findings on IPV in KATROPA Training of Trainers (TOT) and Orientations; to share in PMOC Trainings;
- 3. Work hand in hand with a pool of experts for the conduct of workshops/activities for the target audiences;
- Initiate and/or attend meetings relative to the conduct of activities agreed upon by both parties;
- 5. Share existing materials and other related literatures on IPV and other GADrelated issues and advocacy in the official Facebook account;
- 6. Seek clearance from CPD Central Office for the production of all SBCC materials and other advocacy campaigns/activities, whenever necessary;
- 7. Disseminate all accurate and age-appropriate information during the conduct of Adolescent Health and Development (AHD) and gender and development (GAD) related activities/events in other schools and communities, whenever applicable;
- 8. Conduct monitoring and evaluation of the effectiveness of all the programs, projects and activities with CSU-CBEA.

B. CAGAYAN STATE UNIVERSITY, ANDREWS CAMPUS, CBEA will:

- 1. Provide necessary technical support and/or professional orientation for the conceptualization of all programs, projects and activities relative to the prevention of Intimate Partner Violence (IPV), Adolescent Pregnancy and Child Marriage; VAWC; gender equality; women empowerment; and others;
- 2. In addition to providing technical support and/or professional orientation on matters related to subjects above mentioned, CSU-CBEA expresses willingness

- to support CITY GOVERNMENT OF TUGUEGARAO by conducting workshops or seminars on finance, accounting, and livelihood, given their expertise.
- 3. Collaborate with CITY GOVERNMENT OF TUGUEGARAO in the conduct of its AHD and GAD related activities/events in schools and communities;
- 4. Share other materials that could intensify CITY GOVERNMENT OF TUGUEGARAO's mandate in advocating people-centered development; and also, to intensify campaign against IPV and VAWC
- 5. Provide Resource Persons to discuss GAD-related laws which also includes GBSH related laws such as Safe Spaces Act or the RA 11313 or Bawal Bastos Law, during organization-focused activities of CPD Region II; and
- 6. Provide necessary professional services and materials for special projects (when necessary).

III. WARANTY AUTHORITY

Each person signing this agreement warrants that he or she is duly authorized to do so and bind the representative parties to the agreement.

IV. SEVERABILITY

If any provisions of the Agreement or part thereof is rendered void, illegal or unenforceable by any legislation to which it is subject, it shall be rendered void, illegal or not enforceable only to that extent and no further.

V. DATA PRIVACY

All information whether personal or sensitive that will come to the knowledge of the parties, its employees, personnel and staff as a result of this agreement or by any other means shall be deemed confidential and shall be processed and protected at all times in accordance with the Republic Act No. 10173 (Data Privacy Act of 2012)

VI. OWNERSHIP OF INTELLECTUAL PROPERTY

The parties hereby agree that intellectual property rights, ownership and enjoyment thereof arising from this project shall be governed by the applicable provisions of of RA 10055 (An Act Providing the Framework and Support System for the Ownership, Management, Use, and Commercialization of Intellectual Property Generated from Research and Development funded by Government and for other purposes), RA 8439 (An Act Providing a Magna Carta for Scientists, Engineers, Researchers and other Science and Technology Personnel in Government) and RA 8293 (An Act Prescribing the Intellectual Property Code and Establishing the Intellectual Property Office, Providing for Its Powers and Functions and Regulation, as well as all other existing and future policies of the government and the parties on Intellectual Property Rights.
