MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This agreement made and entered into by and between:

F.L. Vargas College, Inc. an educational institution duly recognized and existing under and by virtue of the Philippine laws, and a duly recognized institution by the Commission on Higher Education (CHED) with postal address at <u>Tuguegarao City</u>, <u>Cagayan</u>, herein represented in this act by <u>RANDY F. APATTAD</u>, <u>MMPA</u>, the <u>Vice President for Academic Affairs</u> hereinafter referred to as the FIRST PARTY;

and

<u>Public Safety and Security Office</u> a duly organized government agency. With office address at <u>Tuguegarao City</u>, <u>Cagayan</u> and herein represented in this act by <u>HON. MAILA ROSARIO T. QUE</u> the incumbent <u>City Mayor</u>, herein referred to as the **SECOND PARTY**:

WITHNESSETH: That

WHEREAS the FIRST PARTY is a higher educational institution who accepts enrollees under the duly recognized program, the BS in Criminology of the Commission on Higher Education where OJT and other programs are offered as part of the curriculum.

WHEREAS, the SECOND PARTY is a duly organized government agency.

Now therefore premises considered, the parties mutually agree to the following:

- 1. The FIRST PARTY shall accept enrollees for the ON-THE-JOB TRAINING/COMMUNITY IMMERSION PROGRAM;
- 2. The SECOND PARTY shall accommodate students on shifting schedule enrolled under said course/program of the FIRST PARTY for learning, experience and technical assistance and therefore, agrees and allows the duly enrolled students to be assisted by herein SECOND PARTY's expertise for the semester where said subject enrolled is being taken subject to policies, procedures and guidelines for evaluation from the said FIRST PARTY;
- 3. The public officer of the Agency representing that SECOND PARTY shall not be responsible of injuries that may be sustained by the students during the course of their training or acts of negligence of the students and for acts beyond the control of the institution represented;
- 4. Witnessed further, that the FIRST PARTY shall comply with the provisions of the afforested conditions and any violation hereof, shall be a legitimate ground for cancellation of this agreement.
- 5. The term of this Memorandum of Agreement is from <u>F.L. Vargas College, Inc.</u> to <u>POSU</u>.
