#### BARANGAY ORDINANCE NO. 03 Series of 2024

#### **PROPOSED:**

# AN ORDINANCE REGULATING THE SALE OF INTOXICATING DRINKS AND CIGARETTES TO MINORS

Sponsored: HON. JESUS M. LAMUD Sangguniang Barangay Member

Co-Sponsored: HON. SANJO C. SORIANO Sangguniang Kabataan Chairperson

WHEREAS, Section 13 of the 1987 Philippine Constitution provides that the State recognizes the vital role of the youth in nation-building and shall promote and protect their physical, moral, spiritual, intellectual, and social being. It shall inculcate in the youth patriotism and nationalism, and encourage their involvement in public and civic affairs;

WHEREAS, the Local Government Code of 1991 (Republic Act No. 7160) accords every local government unit power and authority to promote the general welfare within its territorial jurisdiction, including the promotion of health and safety of its constituents;

WHEREAS, the Barangay of Cataggaman Nuevo recognizes that local governments must act with urgency to denormalize the culture of smoking and intoxicating drinks through comprehensive and proven effective control measures;



NOW, THEREFORE, on motion of Hon. Jesus M. Lamud;

# **BE IT ORDAINED** by the **SANGGUNIANG BARANGAY OF CATAGGAMAN NUEVO IN SESSION ASSEMBLED**, to enact this **ORDINANCE**:

Section 1. SHORT TITLE. This ordinance shall be known and cited as "Operation Totoy Iwas Bisyo".

**Section 2. COVERAGE.** This ordinance shall apply to all persons who are within the territorial jurisdiction of Cataggaman Nuevo, Tuguegarao City.

**Section 3. DEFINITION OF TERMS.** The following terms and phrases shall be interpreted as indicated herein when used in this Ordinance.

- 1. "Minor" shall refer to any person below (18) years of age;
- "Cigarette" shall refer to any roll or tubular construction which contains tobacco or its derivative and is intended to be burned or heated under ordinary condition of use;
- 3. **"Intoxicating Drinks/Alcoholic Beverages"** shall refer to any drink that contains alcohol and can alter the state of consciousness or impair cognitive and physical functions of a person when ingested.

#### Section 4. PUNISHABLE ACTS.

- 1. No owner or operator of sari-sari stores, liquor shops, cigarette vendors or peddlers, or any person who has possession of any tobacco products or alcoholic beverages, shall sell and/or distribute such to minors.
- 2. No person shall direct, instruct, or request a minor to purchase any tobacco products or alcoholic beverages.
- 3. The owner or operator of sari-sari stores, liquor shops, cigarette vendors, peddlers, or any person in possession of tobacco products or alcoholic beverages is required to verify the age of anyone attempting to purchase cigarettes or intoxicating substances by requesting a valid identification document.
- 4. Verification Requirement- Owners or operators of sari-sari stores, liquor shops, cigarette vendors, peddlers, or any person in possession of any tobacco products or alcoholic beverages are required to verify the age of any person attempting to purchase any tobacco products or alcoholic beverages by requesting a valid identification document.

**Section 5. PENALTY CLAUSE.** Any person caught in violation of the aforementioned provision shall bear the penalty of:



**1.** For Sellers: Any person, business, or establishment found in violation of this ordinance shall be subject to a fine:

First Offense – Warning Second Offense – Penalty of five hundred pesos (PHP 500.00) Third Offense – Penalty of one thousand pesos (PHP 1,000.00)

**2. For Minors:** Minors found in possession of cigarettes or intoxicating substances shall be referred to appropriate rehabilitation or counseling programs as determined by local authorities.

### Section 6: Implementation

- 1. **Enforcement:** This ordinance shall be enforced by the Barangay Officials and Barangay Police with the cooperation of local government units.
- 2. **Public Awareness:** The Barangay shall undertake public awareness campaigns and public hearing to inform the community about the provisions and importance of this ordinance. The Sari- Sari Store owners will be mandated to print signages about the ordinance.

**Section 7. SEPARABILITY CLAUSE.** Should any provision of this ordinance be subsequently declared unconstitutional, unlawful, or illegal, the other provisions not so declared shall remain in full force and effect.

**Section 8. EFFECTIVITY.** This ordinance shall take effect fifteen (15) days after its posting in conspicuous places within Barangay Cataggaman Nuevo.

### Proceedings:

The program for this public hearing started off with preliminaries, an invocation and the singing of the Philippine National Anthem led by SK Secretary, Mr. John Paulo D. Calagui. This was followed by the opening remarks of the Presiding Officer, Punong Barangay Waldo L. Zingapan. He stressed on the need to establish stricter guidelines for the sale of alcoholic beverages and tobacco products to individuals under the legal age.

The prepared draft of the said ordinance was read and presented by Sangguniang Kabataan Chairperson Hon. Sanjo C. Soriano. After this, reaction on the provisions of the different sections were solicited from the constituents. So far only one observation was brought out for clarification. Ms. Jelly Carpio, asked regarding the situation "Kung sakali yung legal age ang bumili, tapus binigay niya sa mga minors, sino ang mananago, may penalty ba yung store owner na pinagbilhan niya?. The co-sponsor of the ordinance said that, no penalty will be charged to the store owner, only the legal age buyer shall be referred to appropriate action as determined by local authorities and for the minors shall be subjected to the found violation under Section 4: Penalties of the ordinance.

There being nothing more to clarify of to suggest about this ordinance, a motion for its approval was extended. This was duly seconded and unanimously approved by the body.



Following this, the council members were requested to give some remarks. Most of them expressed their pleasure and thanks for the success of this gathering.

The presiding officer ended up expressing his expectation that this ordinance is well understood and followed seriously to benefit the entire constituency.

It was likewise agreed upon that copies of this ordinance shall be posted in some conspicuous or strategic places and posted in the social media page of the barangay for the information of the public.

And with nothing more to take up, the gathering was adjourned at 9:55 AM.
