

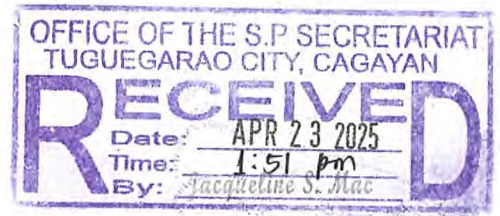

In view of the request submitted by Goldsmith Gaming Corporation, this office respectfully recommends the endorsement of their request to amend the Resolution of No Objection (RONO) previously granted to them by the Sangguniang Panlungsod of Tuguegarao City.

The corporation seeks to expand their electronic gaming operations to include all PAGCOR-approved games, such as traditional and electronic bingo, as part of their enhanced service offerings to their clientele.
