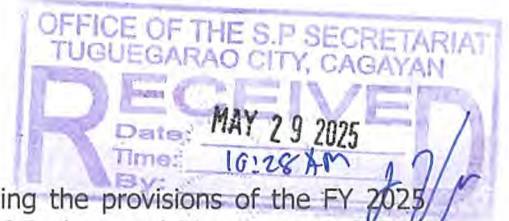

May we reiterate our letter dated May 19, 2025, regarding the provisions of the FY 2025 General Appropriations Act (GAA) and the Department of Budget and Management (DBM) guidelines under the DBM National Budget Circular for the 2025 GAA release of funds which provides for specific requirements that must be met to facilitate the release of funds for new appropriations categorized as Conditional Implementation (CI).

Please be informed that non-compliance or delays in submitting the required documents may result in the deferment of the fund release.


