RESOLUTION NO. 2025-11-322

RESOLUTION LIFTING THE STATE OF CALAMITY IN THE PROVINCE OF CAGAYAN DUE TO TYPHOON "JULIAN," AS RECOMMENDED BY THE PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (PDRRMC)

WHEREAS, the Sangguniang Panlalawigan of Cagayan, through Resolution No. 2024-11-893, declared the entire province under a State of Calamity on October 7, 2024, following the extensive damage caused by Typhoon "Julian" to agriculture, fisheries, infrastructure, and livelihood across multiple municipalities;

WHEREAS, pursuant to Section 21 of Republic Act No. 10121, otherwise known as the "Philippine Disaster Risk

Reduction and Management Act of 2010," the duration of a State of Calamity shall not exceed three (3) months unless justified by prevailing conditions that continue to impair recovery and rehabilitation efforts;

WHEREAS, after a comprehensive assessment and evaluation conducted by the Provincial Disaster Risk Reduction and Management Office (PDRRMO) and in coordination with the concerned Local Government Units (LGUs), it has been confirmed that the conditions that necessitated the declaration of a State of Calamity have significantly improved;

WHEREAS, the successful implementation of response and recovery programs, including the distribution of relief goods, utilization of the Quick Response Fund (QRF), rehabilitation of key public infrastructure, and support to displaced families and affected communities, have led to the restoration of normalcy in the majority of the affected areas; and,

WHEREAS, the PDRRMC has issued Resolution No. 01, Series of 2025, recommending the lifting of the State of Calamity in the Province of Cagayan effective January 7, 2025, corresponding to the end of the 90-day period since its initial declaration.

NOW THEREFORE, on motion of Hon. Mila Perpetua A. Catabay – Lauigan, Board Member, duly seconded, be it:

RESOLVED, AS IT IS HEREBY RESOLVED, TO LIFT THE STATE OF CALAMITY IN THE PROVINCE OF CAGAYAN DUE TO TYPHOON "JULIAN," AS RECOMMENDED BY THE PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (PDRRMC)

RESOLVED FURTHER, that moving forward, before the Sangguniang Panlalawigan acts on any recommendation to lift a State of Calamity, the PDRRMC must first submit a clear and complete report showing what actions were taken, how funds were used, and how recovery efforts helped bring back normalcy to affected communities.

RESOLVED FINALLY, to furnish copies of this Resolution to the Department of the Interior and Local Government (DILG), the Provincial Disaster Risk Reduction and Management Office (PDRRMO), and all concerned agencies for their information and appropriate action.



A RESOLUTION RECOMMENDING TO THE SANGGUNIANG PANLALAWIGAN OF CAGAYAN THE LIFTING OF THE STATE OF CALAMITY IN THE PROVINCE OF CAGAYAN DUE TO TYPHOON "JULIAN"

WHEREAS, the Province of Cagayan was declared under a State of Calamity on October 7, 2024, through Sangguniang Panlalawigan Resolution No. 2024-11-893, following the severe effects of Typhoon "Julian," which caused widespread damage to agriculture, fisheries, infrastructure, and livelihood across the province;

WHEREAS, pursuant to Section 21 of Republic Act 10121 and related guidelines, the duration of the State of Calamity shall not exceed three (3) months unless conditions require an extension, which must be justified by circumstances affecting recovery efforts;

WHEREAS, it has been determined that 90 days have passed since the declaration, and the conditions that warranted the State of Calamity have significantly improved, as validated by the Provincial Disaster Risk Reduction and Management Office (PDRRMO) and Local Government Units (LGUs);

WHEREAS, response and recovery interventions have been successfully implemented, including the release of the Quick Response Fund (QRF), the provision of relief assistance, the rehabilitation of essential infrastructure, and the restoration of normalcy in affected communities;

WHEREAS, the Provincial Government, through the PDRRMO, has ensured that the affected sectors have sufficiently recovered, making it appropriate to recommend the lifting of the State of Calamity;

NOW, THEREFORE, upon motion duly seconded, the PDRRMC hereby resolves to recommend the following:

- 1. To endorse to the Sangguniang Panlalawigan of Cagayan the lifting of the State of Calamity in the Province of Cagayan due to Typhoon "Julian," effective January 7, 2025, marking 90 days from its declaration.
- To commend the Provincial Government, LGUs, and all agencies involved in response and recovery efforts for their proactive measures that have contributed to the restoration of normalcy in the affected areas.
- 3. To direct the PDRRMO to continue its post-rehabilitation monitoring and capacity-building efforts to ensure the sustainability of recovery initiatives.

RESOLVED FURTHER, that copies of this resolution be furnished to the Sangguniang Panlalawigan of Cagayan, the Department of the Interior and Local Government (DILG), and all concerned agencies for their information and guidance.



CITY RESOLUTION NO. 601-09-2024

RESOLUTION DECLARING A STATE OF CALAMITY IN TUGUEGARAO CITY DUE TO THE-DAMAGES CAUSED BY SEVERE TROPICAL STORM KRISTINE

WHEREAS, Section 458 (1) (iv) of the Local Government Code of 1991 provides that the Sangguniang Panlungsod shall "adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and in their return to productive livelihood following said events":

WHEREAS, Section 2(p) on the Declaration of Policy of Republic Act 10121, also known as the "Philippine Disaster Risk Reduction and Management Act of 2010", states that it shall be the policy of the State to provide maximum care, assistance and services to individuals and families affected by disaster, implement emergency rehabilitation projects to lessen the impact of disaster and facilitate resumption of normal social and economic activities.

WHEREAS, the City Mayor, Hon. Maila Rosario S. Ting-Que, has indorsed to the Ninth City Council City Disaster Risk Reduction and Management Council (CDRRMC) Resolution No. 03-2024 Recommending the Declaration of Tuguegarao City Under the State of Calamity due to Severe Tropical Storm Kristine;

WHEREAS, Tuguegarao City was devastated by Severe Tropical Storm Kristine displacing individuals and causing severe damages to agriculture sector amounting to Ten Million One Hundred Ninety-Nine Thousand Seven Hundred Forty-Two Pesos and Sixty Centavos (P10,199,742.60);

WHEREAS, the City Mayor, Hon. Maila Rosario S. Ting-Que, requested for the holding of a Special Session on November 7, 2024 for the declaration of Tuguegarao City under a State of Calamity;

WHEREAS, there is a need to declare Tuguegarao City under the State of Calamity for the provision of essential farm inputs, such as seeds, fertilizers and equipment, to enable farmers rebuild their operations and ensure food security as well as to promote resilience against future natural disasters;

WHEREAS, the Ninth City Council during its Special Session held on November 7, 2024 deemed it proper, necessary and beneficial to the constituents of Tuguegarao City, hence this resolution.

NOW, THEREFORE, RESOLVE, as it is hereby RESOLVED, to declare a State of Calamity in Tuguegarao City due to the damages caused by Severe Tropical Storm Kristine.

RESOLVED FURTHER, that necessary measures be undertaken to facilitate the rescue, recovery, relief, rehabilitation and return to productive livelihood of the affected citizenry of Tuguegarao City.

On motion of Hon. Mangada and without any objection, CITY RESOLUTION NO. 601-09-2024 was APPROVED.
