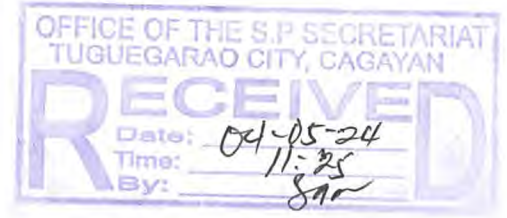

CONTRACT OF SERVICE

KNOW ALL MEN BY THESE PRESENTS:

This contract executed and entered into by and between-

The **CITY GOVERNMENT OF TUGUEGARAO**, represented by **HON. MAILA ROSARIO S. TING-QUE**, City Mayor, of legal age, married and resident of Tuguegarao City, Cagayan HEREINAFTER REFERRED TO AS "FIRST PARTY"

-and-

DR. DOMINADOR M. CENTENO, of legal age, married and resident of Door 4 Ann-Paulo Apartment, Bartolome Street, Caggay, Tuguegarao City, Cagayan, hereinafter referred to as the "SECOND PARTY"

WITNESSETH:

WHEREAS, the FIRST PARTY owns and operates the Tuguegarao City People's General Hospital (TCPGH), a first level, 68-bed capacity hospital situated at the corner of Luna and Rizal Streets, Centro 6, Tuguegarao City, Cagayan;

WHEREAS, the TCPGH has no licensed Radiologist/ Ultrasonologist;

WHEREAS, the SECOND PARTY is a duly licensed Radiologist/ Ultrasonologist, well trained practitioner, with sufficient experience and skills in Radiology/ Ultrasonology;

WHEREAS, the SECOND PARTY offered his professional services as Radiologist/ Ultrasonologist to the TCPGH on a contractual basis and the FIRST PARTY accepted his offer;

NOW, THEREFORE, for an in consideration of the foregoing, the FIRST PARTY and the SECOND PARTY have mutually agreed and covenanted, to wit:

1. That the SECOND PARTY shall render services to the Tuguegarao City People's General Hospital as Radiologist/ Ultrasonologist on a contractual basis beginning March 15, 2024 to March 15, 2026;
2. In consideration of her services, the FIRST PARTY shall compensate the SECOND PARTY in the amount of THIRTY THOUSAND PESOS (PhP30,000.00) per month, to be paid every *quincena*, chargeable against the TCPGH Budget for 2023-2024.
3. That the SECOND PARTY shall report for work at least 20 hours a week, the time and schedule of which shall be agreed by the parties. The SECOND PARTY shall register his attendance using the LOGBOOK.
4. It is hereby understood that this contract does not create an employer-employee relationship between the parties. That the services rendered are not considered government service and that the SECOND PARTY is not entitled to the benefits enjoyed by regular personnel of the FIRST PARTY;
5. The FIRST PARTY reserves the right to unilaterally TERMINATE this contract anytime during the duration of this contract by giving advance written notice for at least fifteen (15) days to the SECOND PARTY. In the same manner, should the SECOND PARTY decide to terminate this Contract, she must give the FIRST PARTY advance written notice for at least fifteen (15) days.

6. This contract shall take effect on February 1, 2023 until January 31, 2024 renewable upon agreement of both parties.
