ORDINANCE NO. 01-2023

AN ORDINANCE PROHIBITING DOUBLE PARKING ALONG VALENZUELA STREET AND IMPOSING PENALTIES THEREOF

WHEREAS, among the powers vested by the Local Government Code to barangays is the promotion of health and safety, maintenance of peace and order, and the preservation of the comfort and convenience of its inhabitants pursuant to Section 16, of Republic Act No. 7160;

WHEREAS, Valenzuela Street, a barangay road traversing from Gonzaga Street in the North to Aguinaldo Street in the South, is a busy thorough fare for motorists and the public;

WHEREAS, Valenzuela Street has been utilized by owners of vehicles as garage and double parking on both sides of the street to the detriment and prejudice of motorists and pedestrians;

WHEREAS, notwithstanding public demands and repeated notices by Barangay Officials and Police Authorities, vehicle owners persist in using the street indiscriminately as garage and double parking purposes daily in utter violation of road clearing policy of the government.

NOW, THEREFORE, on joint motion of all members present, be it ORDAINED by the Barangay Council in session assembled to enact Ordinance No. 01-2023, an "Ordinance Prohibiting Double Parking Along Valenzuela Street And Imposing Penalties Thereof".

SECTION 1. TITLE. This Ordinance shall be known as "An Ordinance Prohibiting Double Parking Along Valenzuela Street And Imposing Penalties Thereof".

SECTION 2. OBJECTIVE. The Ordinance is in compliance with the "Road Clearing program of the National Government on road obstructions pursuant to DILG Circular No. 2019-121.

SECTION 3. COVERAGE. The Ordinance shall govern all types of vehicles and conveyances including tricycles, single motorcycles, carts and calesas.

SECTION 4. DEFINITION OF TERMS

- a. Parking Area refers to places as station for immobilized vehicles.
- b. Garage shall mean an area as station for immobilized vehicles.
- c. Double Parking shall mean stationing for an indefinite period of time of vehicles on both sides of a road, street or through fare along its sidewalks.
- d. Sidewalk refers to free and open passageways for pedestrians on both sides of a road, street or through fare.

SECTION 5. NO DOUBLE PARKING ALONG VALENZUELA STREET

a. Strictly NO DOUBLE PARKING along Valenzuela Street from Gonzaga Street to Aguinaldo Street to prevent obstructions to residential ingress and egress, free flow of traffic and undue inconvenience to inhabitants and motorists.

SECTION 6. ENFORCEMENT OF THE ORDINANCE

a. The Barangay Tanods as agents of persons in authority are hereby deputized to strictly implement the import of the Ordinance in full force and effectively.

SECTION 7. PENALTIES

- a. First Offense fine of two hundred (Php 200.00) pesos.
- b. Second Offense fine of five hundred (Php 500.00) pesos.
- c. Third Offense fine of one thousand (Php 1,000.00) pesos.

SECTION 8. SEPARABILITY CLAUSE. Should any section or provision of this Ordinance be declared as unconstitutional or invalid, other provisions which are not affected thereby shall continue to be in full force and effect.

SECTION 9. REPEALING CLAUSE. Local ordinances or legislations inconsistent with this Ordinance are hereby modified or repealed accordingly.

SECTION 10. EFFECTIVITY. This Ordinance shall take effect immediately upon its approval.
