

Dear Honorable Ting-Que,

This is to respectfully request your endorsement to the 10th City Council for the issuance of a resolution allowing the interim suspension of certain provisions of City Ordinance No. 01-2005, otherwise known as the Tuguegarao City Public Market Code of 2005.

This request is made in view of the temporary use of the Old Public Market building, which has remained vacant and unused since the transfer of vendors to Macapagal Avenue during the construction of the New Don Domingo Public Market. The proposed temporary use aims to accommodate ambulant vendors currently occupying Macapagal Avenue, a major thoroughfare that is not suited for vending activities due to traffic, safety, and cleanliness concerns.

The Old Public Market building, situated adjacent to the new market facility, presents a practical and strategic alternative location for these vendors. This temporary relocation shall remain in effect until the formal opening of the new public market building.

In this regard, it is proposed that the provisions under the Market Code concerning-market rental fees and the formal process of awarding stalls be temporarily suspended for the duration of this interim period. This will allow for a more flexible and immediate response to the current public order and safety concern posed by street vending along Macapagal Avenue.

The temporary use of the old facility will help:

- 1. Clear the Macapagal Avenue of illegal vending and obstructions;
- 2. Provide a safer, more organized environment for vendors and consumers;
- 3. Maximize the use of a public facility that is currently idle;
- 4. Facilitate a smoother transition to the new market operations.

In light of the above, may I respectfully request your favorable endorsement to the Sangguniang Panlungsod for the adoption of a resolution effecting the interim suspension of relevant provisions of City Ordinance No. 01-2005, specifically on market fees and stall awarding procedures, limited to the purpose and period stated herein.

Thank you for your continued support and leadership. We remain committed to ensuring an orderly, safe, and inclusive public market environment for all.
