***BARANGAY ORDINANCE No. 20 SERIES OF 2024 "AN ORDINANCE SETTING-UP BARANGAY COMMUNITY GARDENS AND ALLOCATING FUNDS THEREOF FOR THE IMPLEMENTATION OF THE HALINA'T MAGTANIM NG PRUTAS AT GULAY (HAPAG) SA BARANGAY PROJECT."***

**ACTION TAKEN:**

The members of the committees met to discuss the subject matter with the presence of the resource persons/speakers:

**FINDINGS:**

1. Memorandum Circular No.47 signed by Executive Secretary Lucas Bersamin in April 19, 2024, enjoin all government agencies and Local Government Units (LGUs) to support the implementation of Enhance Partnership Against Hunger and Poverty (EPAHP) Program to mitigate hunger and promote food and nutrition security.
2. DILG Memorandum Circular No. 2023-001 was issued introducing Halina't Magtanim ng Prutas at Gulay (HAPAG) sa Barangay Project which aims to strengthen the capabilities of Barangay towards sustainable agriculture initiatives to include agriculture related activities such as barangay community gardening, wherein household are encourage to have their own backyard garden.
3. The barangay have existing communal & medicinal gardens which they intend to expand and improve.
4. The Barangay Council have already identified vacant lots for the establishment of community gardens and coordination with the lot owners have been done.
5. The amount of P10,000.00 shall be allocated for the operationalization of the program chargeable under the Barangay Maintenance & Other Operating Expenses

**RECOMMENDATION:**

Finding the Barangay Ordinance No.20-2024 titled " An Ordinance Setting-up Barangay Community Gardens and Allocating Funds thereof for the Implementation of the Halina't Magtanim ng Prutas at Gulay (HAPAG) sa Barangay Project." to be in order, with merit and beneficial to the constituents of Barangay Cataggaman Viejo, the committees favorably recommend for its approval with the following suggestion:

**ACTION TAKEN:**

The members of the committee met to discuss the subject matter with the presence of the resource persons.

**FINDINGS:**

1. The Barangay Cataggaman Viejo has now a BARANGAY ECO-PARK, located at Old Provincial Road, Gannaban Street Extension, facing the Cagayan River.
2. The Barangay Council recognizes that the Barangay Eco-Park serves as a venue for family recreation, as well as a place for community gathering, and as such, shall promulgate measures for their maximum benefit.
3. The Barangay Council needs to improve the eco-park and provide measure for its beautification, development, maintenance and management.
4. Concerned government institutions, non-government organizations, barangay-based institutions, Sangguniang Kabataan and other community organizations shall be encourage to get involved in the beautification, development and maintenance of the eco-park.
5. The barangay residents are enjoined to assist in the beautification, development and maintenance of the eco-park.

**RECOMMENDATION:**

1. Republic Act No.7743, mandates the establishment of Barangay Reading Center in order to promote the moral and intellectual well-being of the people, elevate the literacy level of every Filipino, and recognize the vital role of knowledge and information in nation-building.
2. The Barangay Council further deems it essential and imperative to modernize the Barangay Cataggaman Viejo Reading Center by making it more attuned to the latest technological advancement available in the digital information age.
3. The Barangay Council finds it necessary for the adoption of electronic library system in order to provide electronic and online resources to students in the barangay to enhance their educational development and provide educational resources for effective learning and research activities.

**RECOMMENDATION:**


After a thorough review on the Barangay Ordinance No. 26 Series of 2024 titled “An Ordinance Establishing the Barangay Library and Internet Center of Barangay Cataggaman Viejo, Tuguegarao City, and for Other Purpose Thereof.”, the committees finds the ordinance to be in order, with merit and beneficial to the barangay constituents , the committees favorably recommend for its approval with the following amendments:

- A. ) Collation of funds for the purpose shall be sourced out from the General Fund of the Barangay and Sangguniang Kabataan Funds in consultation with the Sk Chairman.
- B. ) Under Section 2 - Organizational Structure, the Library and Internet Center Board shall be composed of the Chairman of the Committee on Education as the Chair and the Sangguniang Kabataan Chairman as the Vice Chair.
