BARANGAY ORDINANCE NO. 01-2024

ORDINANCE PROHIBITING STRAY ANIMALS FROM ROAMING OR WANDERING WITHIN THE TERRITORIAL JURISDICTION OF BARANGAY CATAGGAMAN PARDO, TUGUEGARAO CITY AND PROVIDING PENALTIES FOR VIOLATION THEREOF

SECTION 1. TITLE. This ordinance shall be known as the **ORDINANCE PROHIBITING STRAY ANIMALS FROM ROAMING OR WANDERING WITHIN THE TERRITORIAL JURISDICTION OF BARANGAY CATAGGAMAN PARDO, TUGUEGARAO CITY AND PROVIDING PENALTIES FOR VIOLATION THEREOF.**

SECTION 2. PURPOSE AND SCOPE. The purpose of this ordinance is to adopt new ordinance with penalties to deter proliferation of stray animals within the territorial jurisdiction of this barangay.

SECTION 3. DEFINITION OF TERMS

STRAY ANIMALS- are domestic animals that are wandering at large or are lost.

PUBLIC PLACE- refers to a location to which all of the public has access and is not a place exclusively used for private gathering or any other personal purposes.

PRIVATE PLACE- refers to a place that is exclusively used by one or more individuals for a private gathering or other personal purpose.

LARGE CATTLE- includes cow, carabao, horse, mule, ass or other domesticated member of the bovine family.

PET- a domestic or tamed animal kept for companionship or pleasure

BARANGAY POUND OR ANIMAL SHELTER- is a place where stray, lost, abandoned animals are housed.

IMPOUNDING AUTHORITIES- are local government personnel authorized to enforce and implement the ordinance.

SECTION 4. DESIGNATION OF BARANGAY POUND OR ANIMAL SHELTER. For the purpose of this ordinance, the Punong Barangay shall designate a place as Barangay Pound or Animal Shelter where impounded animals will be kept or deposited.

SECTION 5. IMPOUNDING OF STRAY ANIMALS. Any stray animals found and caught by impounding authorities within the territorial jurisdiction of the barangay shall be impounded.

SECTION 6. IMPOSITION OF FEES. The following fees are hereby imposed for the impounding of stray animals to wit;

All kinds of animals-----P 50.00/day

SECTION 7. ADMINISTRATIVE PROVISIONS.

1. The Barangay Officials/ Tanods shall apprehend any stray animals, which shall be recorded in a logbook.
2. Impounded animals not claimed within three (3) months from impounding shall be sold at public auction under the following procedures:
 - a. The Barangay Treasurer shall post notice for ten (10) days in three conspicuous places including the Barangay Hall. The animals shall be sold to the highest bidder.
 - b. The owner of the stray animal may stop the sale by paying at any time before or during the auction sale, the impounding fee, advertisement, conduct of auction sale and penalty to the Barangay Treasurer, otherwise, the auction sale shall proceed.
 - c. The proceeds of the sale shall be applied to satisfy the impounding fee, advertisement, conduct of auction sale and penalty. The residue over these cost shall accrue to the General Fund of the Barangay; and
 - d. In case the impounded animal is not disposed of within ten (10) days from the date of notice of public auction, the same shall be considered property of the Barangay Government.

SECTION 8. PENALTY CLAUSE. Owners whose animals are caught stray and incurring damages to plants and properties shall pay the corresponding fines:

1st Offense-----P 300.00

2nd Offense-----P 400.00

3rd Offense-----P 500.00


In addition to the fine, the owner shall pay the cost of damages incurred to the property owner.

SECTION 9. SEPARABILITY CLAUSE. If any section or part of this ordinance is held invalid or unconstitutional, the other sections or provisions not affected shall remain in full force and effect.


SECTION 10. REPEALING CLAUSE. All ordinances, resolutions, rules and regulations which are inconsistent with the provisions of this ordinance are hereby repealed, amended or modified accordingly.


SECTION 11. EFFECTIVITY. This Ordinance shall take effect upon its approval.




